An Act relative to the Historic Connecticut River Water Trail.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. (a) There is hereby established a Historic Connecticut River Water Trail  
2 Marking Trust Fund. The trust fund is established given that the unique nature of the Connecticut  
3 River Water Trail has precluded it from benefiting from conventional sources of funding that  
4 would be utilized to ensure safe navigable passage and recreation.

5           (b) The Historic Connecticut River Water Trail shall be defined as the portion of the  
6 Connecticut River beginning at the Holyoke Dam located at river mile 83.4, and ending at the  
7 northern border of the municipality of Hatfield located at river mile 104.3.

8           (c) The funds of the Historic Connecticut River Water Trail Marking Trust Fund shall be  
9 expended, without further appropriation, by the executive office of energy and environmental  
10 affairs in consultation with its office of outdoor recreation and the municipalities of  
11 Easthampton, Hadley, Hatfield, Holyoke, Northampton and South Hadley.

12 (d) The funds of the Historic Connecticut River Water Trail Marking Trust Fund shall be  
13 expended for purposes related to ensuring safe navigable passage and recreation on the Historic  
14 Connecticut River Water Trail. Such expenditures shall include, but are not limited to, the  
15 provision of river markers and the administration of a Connecticut River waterway permit  
16 program as specified in section 2, with the objective of establishing a self-sustaining program  
17 that funds its operational costs.

18 (e) The fund shall consist of: (i) money transferred to the fund by a municipality; (ii)  
19 money transferred to the fund by the municipal gas and electric commission of the city of  
20 Holyoke; (iii) money from the Connecticut river waterway permit established in section 2; (iv)  
21 money collected from the enforcement of the provisions of section 1 and section 2; (v) money  
22 transferred to the fund by the general court and specifically designated to be credited to the fund;  
23 (vi) funds from public and private sources, including, but not limited to, gifts, grants and  
24 donations; and (vii) interest earned on such money. Amounts credited to the fund that are  
25 unexpended at the end of a fiscal year shall not revert to the General Fund.

26 (f) Annually, not later than November 30, the executive office of energy and  
27 environmental affairs shall submit to the joint committee on environment and natural resources  
28 and the clerks of the house of representatives and the senate a report on the fund activity, which  
29 shall include: (i) an accounting of the money received into the fund in the previous fiscal year;  
30 (ii) a breakdown of any money expended from the fund; (iii) information about any navigational  
31 markers placed on the Connecticut river using money from the fund; and (iv) an analysis of the  
32 necessity for additional or improved markers.

33 SECTION 2. (a) Notwithstanding any general or special law to the contrary, no person  
34 shall operate a motorized vessel on the Historic Connecticut River Water Trail as defined in  
35 section 1 without a special permit, issued annually.

36 (b) With the exception of section 2(c) and 2(d), the permit shall cost \$25 per year,  
37 indexed for inflation, and be available for sale.

38 (c) Notwithstanding any general or special law to the contrary, no corporation operating  
39 multiple paddle-craft may provide non-motorized vessels for use on the Historic Connecticut  
40 River Water Trail, as defined in section 1, without a flat rate permit, issued annually. The permit  
41 shall be offered at multiple fixed-fees to be determined by the executive office of energy and  
42 environmental affairs, and be available for sale. The executive office of energy and  
43 environmental affairs shall offer a lower fixed-fee to non-profit organizations that are determined  
44 to promote access, education, and stewardship of the river.

45 (d) Notwithstanding section 2, the executive office of energy and environmental affairs  
46 shall determine a higher permit fee for non-resident of the commonwealth.

47 (e) Any money raised under this section shall be deposited in the Historic Connecticut  
48 River Water Trail Marking Trust Fund, established in section 1.

49 SECTION 3. The executive office of energy and environmental affairs, shall promulgate  
50 or amend any regulations necessary to implement this act, including penalties and fines for  
51 noncompliance with section 1 and section 2.
