1 *Ordered,* That the committee on Health Care Financing be authorized to sit during a
2 recess of the General Court to make an investigation and study of Senate documents numbered
3 67, 757, 760, 775, 795, 808, 1238, 1253 and 1261 and House documents numbered 1184, 1193,
4 1210, 1232, 1867, 1881, 1887, 1924, 1949, 1984, 2006, 2198, 2233, 2245, 2256, 2268, 2986 and
5 3602, relative to perinatal mental health, physical therapy and other health care financing issues.

6 Said committee shall report to the General Court the results of its investigation and study
7 and its recommendations, if any, together with drafts of legislation necessary to carry such
8 recommendations into effect, by filing the same with the Clerk of the House of Representatives
9 on or before December 31, 2024.
