*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Section 43A of chapter 54 of the general laws is hereby amended by  
2 inserting after the word “congressman” the following word:- governor’s

3 SECTION 2. Section 150 of said chapter 54 is hereby amended by inserting after the  
4 word “each,” in line 4, the following word:- governor’s

5 SECTION 3. Said section 150 of said chapter 54 is hereby further amended by inserting  
6 after the word “one,” in line 5, the word:- governor’s
