By Representative Blais of Deerfield, a petition (accompanied by bill, House, No. 756) of Natalie M. Blais, Mindy Domb and Aaron L. Saunders that the Executive Office of Energy and Environmental Affairs be authorized to establish the office of outdoor recreation. Environment and Natural Resources.

The Commonwealth of Massachusetts

**In the One Hundred and Ninety-Third General Court
(2023-2024)**

An Act establishing an office of outdoor recreation.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Chapter 21A of the General Laws is hereby amended by adding the
2 following section:-

3 Section 7C. (a) There shall be within the executive office of energy and environmental
4 affairs, the office of outdoor recreation. The office of outdoor recreation shall be administered by
5 a director who shall be appointed, and may be removed, by the secretary. The position of director
6 shall not be subject to the provisions of chapter 31 or section 9A of chapter 30.

7 (b) “Recreational use”, active or passive recreational use including, but not limited to,
8 activities that take place predominantly in a natural environment or a natural physical landscape,
9 including activities that are dependent on trails, natural landscapes, waters, and snow;
10 community gardens; and parks and nature-based playgrounds. Recreational use shall not include
11 horse racing or indoor stadiums, gymnasiums, or similar structures.

12 (c) The Director will create and implement a strategic plan to achieve the following
13 objectives:

14 Promote the Massachusetts outdoor recreation economy through partnerships with
15 businesses, non-profit organizations, and local communities to advance outdoor recreation as an
16 economic driver; advance equity and access to outdoor recreation opportunities; coordinate
17 policy and recruit funding across federal, state, regional, and local governments; work with
18 landowners and managers throughout the Commonwealth to promote public access and
19 recreation infrastructure; and promote Massachusetts as a great place to work, live, and recreate,
20 and improve quality of life for residents and visitors.

21 (d) The director of the office of outdoor recreation shall:

22 1. Establish metrics and baselines to evaluate the impacts of programs and initiatives
23 of the office.

24 2. Identify and secure funding for outdoor recreation projects via federal grants and
25 partnerships with non-profit organizations and businesses.

26 3. Serve as the central point of contact for the outdoor recreation industry, and work
27 with industry partners to address potential challenges and opportunities.

28 4. Coordinate with state agencies and secretariats including but not limited to the
29 Massachusetts Office of Travel and Tourism, the Department of Conservation and

30 5. Recreation, the Department of Fish and Game, Housing and Economic
31 Development, and the Department of Public Health to implement cross-agency initiatives and
32 priorities.

33 6. Hire and manage any additional staff, contractors, and interns that may be hired
34 by the office.

35 7. Represent the Commonwealth in regional and national learning networks and
36 utilize best-practices to inform initiatives and priorities.

37 8. Partner with peer agencies, local governments, the federal government,
38 businesses, and non-profit organizations to establish a strategic plan and associated initiatives,
39 projects, and policies to advance the economic, quality of life, natural resource, and health
40 benefits of outdoor recreation, and to ensure they are accessible to all, including those with
41 disabling conditions.

42 9. Identify, recruit, and secure funding for outdoor recreation projects, infrastructure,
43 and programs from federal, non-profit, and private grant programs, and distribute to projects and
44 programs throughout the Commonwealth.

45 10. Develop and build the structure for the Office of Outdoor Recreation, including
46 operational procedures and the hiring/management of contractors and additional staff.

47 11. Represent the Commonwealth at events, conferences, and speaking engagements
48 related to outdoor recreation and the outdoor recreation economy.

49 12. Create and promote marketing materials in coordination with the Massachusetts
50 Office of Travel and Tourism to attract and retain visitors and investment in Massachusetts
51 communities.

52 13. Develop and maintain a network of businesses, non-profits, and government partners
53 who work in the outdoor recreation or outdoor recreation-adjacent fields.

54 14. Develop and maintain metrics to track the Office’s impact and publish an annual
55 report on the website of the executive office of energy and environmental affairs.

56 (e) The director in accomplishing the purposes of the office of outdoor recreation may
57 with the approval of the secretary, expend funds from the Outdoor Recreation Trust Fund as
58 provided under section 2GGGGG of chapter 29.

59 (f) The secretary shall be authorized to adopt regulations necessary for the administration
60 of this section.

61 SECTION 2. The last sentence of section 8 of said chapter 21A, as appearing in the 2018
62 Official Edition, is hereby amended by inserting after the word “enforcement,” in lines 91 and
63 92, the words:- the office of outdoor recreation.

64 SECTION 3. Chapter 29 of the General Laws is hereby amended by adding the following
65 section:-

66 Section 2GGGGG. There shall be established and set up on the books of the
67 commonwealth a separate fund known as the Outdoor Recreation Trust Fund. The purpose of the
68 fund shall be to provide competitive grants for programs, projects and initiatives, to public and
69 private organizations to further the objectives of the office of outdoor recreation, established
70 under section 7C of chapter 21A. The director of outdoor recreation shall administer the fund,
71 subject to the approval of the secretary of energy and environment. Amounts credited to the fund
72 shall without further appropriation, be expended only for the purposes stated in this section.

73 The fund shall consist of all monies credited, received, or transferred to the fund from (i)
74 private or public sources as appropriations, gifts, grants, donations, or receipts, (ii) the federal

75 government as reimbursements, grants-in-aid, or other receipts, and (iii) revenue from investing
76 the monies in the fund. Revenues remaining in the fund at the end of a fiscal year shall not revert
77 to the general fund and shall be available for expenditure in the following fiscal year. The fund
78 shall not be subject to the provisions of section 5D. No expenditure from the fund shall cause the
79 fund to be in deficiency at the end of the fiscal year. The director shall report annually, not later
80 than October 1, on the fund's activities, including information about fund receipts, expenditures
81 and the reason for each such expenditure, and fund balances, to the clerks of the house and
82 senate, and the chairs of the house and senate committees on ways and means.
