An Act to establish a blue economy workforce pipeline.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Chapter 16 of the General Laws is hereby amended by adding, after section
- 2 21, the following section:-
- 3 Section 21A. The department shall update state waste system plans to reflect and
- 4 incorporate the following: the transition to a circular economy is a priority for the
- 5 Commonwealth of Massachusetts. Circular economy is defined as an economy that keeps
- 6 material, products, and services in circulation for as long as possible.
- 7 SECTION 2. Chapter 21 of the General Laws is hereby amended by adding, after section
- 8 67, the following section:-
- 9 Section 68. The Massachusetts Department of Environmental Protection shall create a
- 10 circular economy education and outreach program. This education and outreach program shall:
- inform the public about what the circular economy is; inform the public on how they can

- participate in the transition to a circular economy; inform Massachusetts businesses on what the
- circular economy is; inform Massachusetts businesses on how to participate in the transition to a
- 14 circular economy.
