**In the One Hundred and Ninety-Third General Court
(2023-2024)**

An Act to update mental health parity.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 22 of chapter 32A of the General Laws, as appearing in the 2006
2 Official Edition, is hereby amended by striking out subsection (a) and inserting in place thereof
3 the following subsection:-

4 (a) The commission shall provide to any active or retired employee of the commonwealth
5 who is insured under the group insurance commission coverage on a nondiscriminatory basis for
6 the diagnosis and medically necessary treatment of any mental disorder including autism
7 spectrum disorder, as described in the most recent edition of the Diagnostic and Statistical
8 Manual of Mental Disorders (DSM) or the most current version of the International
9 Classification of Diseases (ICD).

10 SECTION 2. Said section 22 of said chapter 32A, as so appearing, is hereby further
11 amended by striking out subsections (b) and (c).

12 SECTION 3. Section 47B of chapter 175 of the General Laws, as so appearing, is hereby
13 amended by striking out subsection (a) and inserting in place thereof the following subsection:-

14 (a) Section 47B. (a) An individual policy of accident and sickness insurance issued
15 pursuant to section 108, which provides hospital expense and surgical expense insurance, and a
16 group blanket or general policy of accident and sickness insurance issued pursuant to section
17 110, which provides hospital expense and surgical expense insurance, which is issued or
18 renewed within or without the commonwealth, shall provide mental health benefits on a
19 nondiscriminatory basis to residents of the commonwealth and to all policyholders having a
20 principal place of employment in the commonwealth coverage on a nondiscriminatory basis for
21 the diagnosis and medically necessary treatment of any mental disorder including autism
22 spectrum disorder, as described in the most recent edition of the Diagnostic and Statistical
23 Manual of Mental Disorders (DSM) or the most current version of the International
24 Classification of Diseases (ICD).

25 SECTION 4. Said section 47B of said chapter 175, as so appearing, is hereby further
26 amended by striking out subsections (b) and (e).

27 SECTION 5. Section 8A of chapter 176A of the General Laws, as appearing in the 2006
28 Official Edition, is hereby amended by striking out subsection (a) and inserting in place thereof
29 the following subsection:-

30 Section 8A. (a) A contract between a subscriber and the corporation under an individual
31 or group hospital service plan which is issued or renewed within or without the commonwealth
32 shall provide mental health benefits on a nondiscriminatory basis to residents of the
33 commonwealth and to all individual subscribers and members and group members having a

34 principal place of employment in the commonwealth for the diagnosis and medically necessary
35 treatment of any mental disorder including autism spectrum disorder, as described in the most
36 recent edition of the Diagnostic and Statistical Manual of Mental Disorders (DSM) or the most
37 current version of the International Classification of Diseases (ICD).

38 SECTION 6. Section 8A of chapter 176A of the General Laws, as appearing in the 2006
39 Official Edition, is hereby amended by striking out subsections (b) and (e).

40 SECTION 7. Section 4A of chapter 176B of the General Laws, as so appearing, is hereby
41 amended by striking out subsection (a) and inserting in place thereof the following subsection:-

42 (a) A subscription certificate under an individual or group medical service agreement
43 which is issued or renewed within or without the commonwealth shall provide mental health
44 benefits on a nondiscriminatory basis to residents of the commonwealth and to all individual
45 subscribers and members within the commonwealth and to all group members having a principal
46 place of employment in the commonwealth for the diagnosis and medically necessary treatment
47 of any mental disorder including autism spectrum disorder, as described in the most recent
48 edition of the Diagnostic and Statistical Manual of Mental Disorders (DSM) or the most current
49 version of the International Classification of Diseases (ICD).

50 SECTION 8. Section 4A of chapter 176B of the General Laws, as so appearing, is hereby
51 amended by striking out subsections (b) and (e).

52 SECTION 9. Section 4M of said chapter 176G, as so appearing, is hereby further
53 amended by striking out subsection (a) and inserting in place thereof the following subsection:—

55 (a) A health maintenance contract issued or renewed within or without the
56 commonwealth shall provide mental health benefits on a nondiscriminatory basis to residents of
57 the commonwealth and to all members or enrollees having a principal place of employment in
58 the commonwealth for the diagnosis and medically necessary treatment of any mental disorder
59 including autism spectrum disorder, as described in the most recent edition of the Diagnostic and
60 Statistical Manual of Mental Disorders (DSM) or the most current version of the International
61 Classification of Diseases (ICD)

62 SECTION 10. Section 4M of said chapter 176G, as so appearing, is hereby further
63 amended by striking out subsection (b) and (e).

64 SECTION 11. All policies, contracts and certificates of health insurance subject to
65 section 22 of chapter 32A, section 47B of chapter 175, section 8A of chapter 176A, section 4A
66 of chapter 176B, or section 4M of chapter 176G of the General Laws that are delivered, issued or
67 renewed on or after July 1, 2024 shall conform with this act. Form filings implementing this act
68 shall be subject to the approval of the commissioner of insurance.
