In the One Hundred and Ninety-Third General Court (2023-2024)

An Act relative to prevailing wages.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. Section 26 of Chapter 149 of the General Laws, as appearing in the 2014
- 2 Official Edition, is hereby amended by inserting after words "pension plans", in line 46, the
- 3 following:- ", bona fide apprenticeship and training programs approved by the commonwealth
