An Act relative to access to care for serious mental illness.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Chapter 175 of the General Laws is hereby amended by inserting after  
2 section 47PP the following section:

3           Section 47QQ.

4           (a) Any policy, contract, agreement, plan or certificate of insurance issued, delivered or  
5 renewed within the commonwealth, which is considered creditable coverage under section 1 of  
6 chapter 118M, shall provide coverage for medications used to prevent, assess or treat serious  
7 mental illness without requiring prior authorization or the initiation or completion of a step  
8 therapy protocol.

9           (b) For the purposes of this section, the following terms shall have the following  
10 meanings unless the context clearly requires otherwise:

11 "Serious mental illness" means a mental disorder, as defined in the most recent edition of  
12 the Diagnostic and Statistical Manual of Mental Disorders published by the American  
13 Psychiatric Association, that results in serious functional impairment that substantially interferes  
14 with or limits one or more major life activities.
