By Representative Balsler of Newton, a petition (accompanied by bill, House, No. 1966) of Ruth B. Balsler and others relative to access to addiction services. Mental Health, Substance Use and Recovery.

**The Commonwealth of Massachusetts**

**In the One Hundred and Ninety-Third General Court  
(2023-2024)**

An Act ensuring access to addiction services.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1: Section 35 of Chapter 123 of the General Laws, as appearing in the 2020  
2 Official Edition, is hereby amended by striking out the definition of “facility,” and inserting in  
3 place thereof the following definition:-

4 "Facility", a public or private facility that provides care and treatment for a person with an  
5 alcohol or substance use disorder. For the purpose of this section, a "facility" or "secure facility"  
6 shall not include any jail or correctional facility or any other facility funded, controlled, or  
7 administered by a county sheriff, the Executive Office of Public Safety and Security (EOPSS), or  
8 any agency under EOPSS' jurisdiction.

9 SECTION 2: Section 35 of Chapter 123 of the General Laws, as appearing in the 2020  
10 Official Edition, is hereby amended by striking out, in lines 74 to 104, inclusive, the words “If  
11 the department of public health” through “treating persons on a voluntary basis,” and inserting in  
12 place thereof the following:-

13           The Secretary of Health and Human Services shall ensure an adequate supply of beds for  
14 the treatment of alcohol or substance use disorders at facilities licensed or approved by the  
15 Department of Public Health or the Department of Mental Health for persons ordered to be  
16 committed under M.G.L. c. 123, s. 35.

17           If the court makes a specific finding that the only appropriate setting for treatment for the  
18 person is a secure facility, then the person may be committed to a secure facility licensed or  
19 approved by the Department of Public Health or the Department of Mental Health; provided  
20 further, that such secure facilities licensed or approved by the Department of Public Health or the  
21 Department of Mental Health shall be geographically distributed throughout the Commonwealth  
22 so as to provide access to treatment in all regions of Massachusetts.

23           A person committed under this section shall, upon release, be encouraged to consent to  
24 further treatment and shall be allowed voluntarily to remain in the facility for such purpose. The  
25 department of public health shall maintain a roster of public and private facilities available,  
26 together with the number of beds currently available and the level of security at each facility, for  
27 the care and treatment of alcohol use disorder and substance use disorder and shall make the  
28 roster available to the trial court.
