An Act to exclude Chapter 115 payments to veterans from gross household income calculation.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Notwithstanding Section 5, Part 1, Chapter 115 of the General Laws or any  
2 other general or special law to the contrary, and in order to promote the public good, payments  
3 received by veterans as reimbursement for out-of-pocket health care costs shall be added to the  
4 list of Exclusions listed in 760 CMR 6.05 (3) Exclusions from Gross Household Income.

5           SECTION 2. This act shall take effect upon its passage.
