Resolve establishing a special commission to study the impact of telecommuting on employees of the Commonwealth.

1           **Resolved**, that a special commission is hereby established for the purposes of making an  
2 investigation, study and evaluation relative to the impact of telecommuting on employees of the  
3 Commonwealth.

4           The commission shall consist of: 3 members of the Senate, 1 of which shall be appointed  
5 by the Senate Minority Leader, and 1 of which shall be the Senate Chair on State Administration  
6 and Regulatory Oversight who shall serve as co-chair; 3 members of the House of  
7 Representatives, 1 of which shall be appointed by the House Minority Leader, and 1 of which  
8 shall be the House Chair on State Administration and Regulatory Oversight who shall serve as  
9 co-chair; 1 of which shall be the Chief Information Officer of Legislative Information Services,  
10 or their designee; 6 members from the Executive Branch appointed by the Governor, 1 of which

11 shall be the Secretary of Administration and Finance, or their designee, and 1 of which shall be  
12 the Secretary of Technology Services and Security, or their designee and; 1 of which shall be the  
13 Chief Human Resources Officer at the Human Resources Division or their designee; and 1 of  
14 which shall be the Secretary of Energy and Environmental Affairs or their designee; 1 member  
15 appointed by the Attorney General; 1 member appointed by the Treasurer and Receiver General;  
16 1 member appointed by the Secretary of the Commonwealth; 1 member appointed by the State  
17 Auditor; 1 member to be appointed by the Service Employees International Union and; 1  
18 member to be appointed by the National Association of Government Employees.

19 Not later than December 1, 2024, the commission shall file a report of its analysis and  
20 recommendations regarding the efficacy of telecommuting to the clerks of the senate and the  
21 house of representatives, the joint committee on state administration and regulatory oversight,  
22 the office of the senate president, the office of the speaker of the house, and the office of the  
23 Governor.

24 The report shall include but not be limited to: (i) both the costs and potential cost savings  
25 associated with working remotely, (ii) the IT requirements needed to allow remote work, (iii) the  
26 effect of remote work on employee productivity, recruitment and retention, and (iv) the  
27 environmental impact of telecommuting.
