**In the One Hundred and Ninety-Third General Court
(2023-2024)**

An Act improving healthcare delivery for underserved residents of the commonwealth.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Chapter 112 of the General Laws, as appearing in the 2020 Official Edition,
2 is hereby amended by striking out Section 9, and inserting in place thereof the following
3 section:-

4 Section 9.

5 (a) An applicant for limited registration under this section may, upon payment of a fee to
6 be determined annually by the commissioner of administration under the provision of section
7 three B of chapter seven, be registered by the board as an intern, fellow or medical officer for
8 such time as it may subscribe if the applicant furnishes the board with satisfactory proof of the
9 following:

10 (1) The applicant is eighteen or over and of good moral character.

11 (2) (i) The applicant has creditably completed two years of a premedical course of study
12 in a college or university and not less than three and one-half years of study in a legally chartered
13 medical school having the power to grant degrees in medicine; or (ii) if not enrolled in or a
14 graduate of a legally chartered medical school in the United States or Canada, the applicant is the
15 holder of a standard certificate granted after an examination by the Education Council for
16 Foreign Medical Graduates, unless granted an exemption by the board; or (iii) the applicant has
17 completed two years of premedical education in a college or university of the United States,
18 Canada or Puerto Rico and if the applicant has studied medicine in a medical school outside the
19 United States, Canada or Puerto Rico that is recognized by the World Health Organization, has
20 completed all the formal requirements for the degree corresponding to doctor of medicine, except
21 internship and social service, and has completed a year of clinical clerkship approved by the
22 liaison committee on medical education of the American Medical Association.

23 (3) The applicant has been appointed as an intern, fellow or medical officer in a hospital
24 or other institution of the commonwealth, or of a county or municipality thereof, or in a hospital
25 or clinic which is incorporated under the laws of the commonwealth or in a clinic which is
26 affiliated with a hospital licensed by the department of public health under authority of section
27 seventy-one of chapter one hundred and eleven, or in an out-patient clinic operated by the
28 department of mental health, or in the department of public health for duty in clinics or in
29 programs operated or approved by the department of public health, or in programs approved by
30 the board of registration in medicine in the commonwealth and leading toward certification by
31 specialty boards recognized by the American Medical Association.

32 (4) The applicant has applied to participate in the medical assistance program
33 administered by the secretary of health and human services in accordance with chapter 118E and

34 Title XIX of the Social Security Act and any federal demonstration or waiver relating to the
35 medical assistance program for the limited purpose of ordering and referring services covered
36 under the program if regulations governing such limited participation are promulgated under
37 chapter 118E.

38 Such limited registration shall entitle the applicant to practice medicine only in the
39 hospital, institution, clinic or program designated on the applicant's certificate of limited
40 registration, or outside such hospital, institution, clinic or program for the treatment, under
41 supervision of one of its medical officers who is a duly registered physician, of persons accepted
42 by it as patients, or in any hospital, institution, clinic or program affiliated for training purposes
43 with the hospital, institution, clinic or program designated on such certificate, which affiliation is
44 approved by the board and in any case under regulations established by such hospital, institution,
45 clinic or program. The name of any hospital, institution, clinic or program so affiliated and so
46 approved shall also be indicated on such certificate. Limited registration under this section may
47 be revoked at any time by the board.

48 (b) Notwithstanding the other provisions of this section, an internationally-trained
49 physician who has been licensed or otherwise authorized to practice medicine in a country other
50 than the United States shall be eligible to apply for a limited license to practice medicine for a
51 renewable one-year term after satisfying the criteria in below paragraph (3), provided, however,
52 that such limited registration shall provide a pathway for the issuance of a full unrestricted
53 license to practice medicine in accordance with, and upon satisfaction of, the criteria in below
54 paragraph (5).

55 (1) Definitions. For the purposes of this subsection, the following terms shall have the
56 following meanings—

57 (i) “Commission” shall mean the Educational Commission for Foreign Medical
58 Graduates.

59 (ii) “Internationally-trained physician” shall mean a physician who has received a degree
60 of doctor of medicine or its equivalent from a legally chartered medical school outside the
61 United States recognized by the World Health Organization, who has been licensed or otherwise
62 authorized to practice medicine in a country other than the United States, and who has practiced
63 medicine for at least one year.

64 (iii) “Licensing Exam” shall mean United States Medical Licensing Examination.

65 (iv) “Massachusetts physician shortage area” shall mean a geographic region or
66 population in the commonwealth experiencing a shortage of physicians, especially primary care
67 physicians or psychiatrists, relative to population and need.

68 (v) “Participating healthcare facility” shall mean a federally-qualified health center,
69 community health center, hospital, or other healthcare facility approved by the board that
70 provides an assessment and evaluation program designed to develop, assess, and evaluate an
71 internationally-trained physician’s non-clinical skills, according to criteria developed or
72 approved by the board; provided, however, that the participating healthcare facility provides
73 medical care in a Massachusetts physician shortage area.

74 (2) For the purposes of this subsection, the Massachusetts health care workforce center or
75 its equivalent in the department of public health shall assist the board in determining the regions
76 or populations comprising a Massachusetts physician shortage area.

77 (3) The board shall issue a limited license to an applicant if the participating facility and
78 the applicant submit evidence acceptable to the board that the applicant:

79 (i) is an internationally-trained physician;

80 (ii) has a valid certificate issued by the Commission or other credential evaluation service
81 approved by the board, provided, however, that the board may waive such certification at its
82 discretion where the applicant is unable to obtain the required documentation from a non-
83 cooperating country;

84 (iii) has achieved a passing score on Step 1 and Step 2-Clinical Knowledge (CK) of the
85 Licensing Exam;

86 (iv) has entered into an agreement with the participating facility providing that the facility
87 shall develop, assess and evaluate the applicant's familiarity with non-clinical skills and
88 standards appropriate for medical practice in the commonwealth, according to assessment and
89 evaluation criteria developed or approved by the board;

90 (v) shall enter a full-time full employment relationship with the participating facility after
91 the board issues a limited license to practice medicine to the applicant; and

92 (vi) has satisfied other criteria that may be developed by the board in fulfillment of this
93 subsection.

94 (4) The 1-year limited license may be renewed no more than once.

95 (5) An internationally-trained physician who provides the board with proof of (i)
96 successful completion of the participating facility's assessment and evaluation program, (ii) a
97 passing score on Step 3 of the Licensing Exam, and (iii) any additional prerequisites that the
98 board may require, shall be eligible to apply for a renewable 2-year restricted license to practice
99 medicine only in a Massachusetts physician shortage area designated by the board; provided,
100 however, that any additional prerequisites for eligibility shall not include post-graduate clinical
101 training, and that the restricted license shall authorize the holder to practice independently in a
102 primary care specialty, psychiatry, or other specialty approved by the board. After 2 years of
103 restricted practice, the internationally-trained physician shall be eligible to apply for a full,
104 unrestricted license to practice medicine. The 2-year restricted license may be renewed no more
105 than once.
