An Act relative to retirement classification of licensed drinking water operators.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           Section 3 of Chapter 32 of the Massachusetts General Laws subsection (g) is hereby  
2 amended by including "drinking water operators licensed by the Board of Certification of  
3 Drinking Water Supply Facilities pursuant to Chapter 112, Section 87CCCC" in the Group 2  
4 category.
