An Act relative to the veteran allowance for public retirees.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Paragraph (b) of subdivision (2) of section 5 of chapter 32 of the General  
2 Laws, as appearing in the 2022 Official Edition, is amended by inserting after the word “dollars”  
3 the following words:- or upon acceptance of paragraph (b 1/2) fifty dollars.

4 SECTION 2. Paragraph (b) of subdivision (2) of section 5 of said chapter 32, as so  
5 appearing, is further amended by deleting in the words “in any case” and inserting in place  
6 thereof the following words:- or upon acceptance of paragraph (b 1/2) one thousand dollars.

7 SECTION 3. Subdivision (2) of section 5 of said chapter 32 is hereby further amended by  
8 inserting the following new paragraph:-

9 (b 1/2) Upon acceptance of this provision by a retirement system, any member of Group  
10 1 or group 2 or Group 4, who is a veteran as defined in section one, shall receive, in lieu of

11 paragraph (b), an additional yearly allowance of fifty dollars for each year of creditable service  
12 or fraction thereof; provided, that the total amount of said additional retirement allowance shall  
13 not exceed one thousand dollars in any case. Acceptance of this provision by a retirement system  
14 shall be by a majority vote of the board of each such system, subject to the approval of the  
15 legislative body. For the purposes herein, “legislative body” shall mean, in the case of a city, the  
16 city council in accordance with its charter, in the case of a town, the town meeting, in the case of  
17 a county, the county retirement board advisory council, in the case of a region, the regional  
18 retirement board advisory council, in the case of a district, the district members, and, in the case  
19 of an authority, the governing body. Acceptance shall be deemed to have occurred upon the  
20 filing of a certification of such votes with the commission. For purposes herein, the state  
21 teachers’ and state employees’ retirement systems shall be deemed to have accepted this  
22 provision.

23 SECTION 4. Paragraph (e) of subdivision (2) of section 7 of said chapter 32, as  
24 appearing in the 2018 Official Edition, is amended by inserting in line 160 after the dollar  
25 amount “\$15” the following words:- or upon acceptance of paragraph (f) \$50 and is further  
26 amended by inserting in line 162 after the dollar amount “\$300” the following words:- or upon  
27 acceptance of paragraph (f) \$1,000.

28 SECTION 5. Subdivision (2) of section 7 of said chapter 32 is hereby further amended by  
29 inserting at the end thereof the following new paragraph:-

30 (f) Upon acceptance of this provision by a retirement system, any member of Group 1 or  
31 group 2 or Group 4, who is a veteran as defined in section one, shall receive, in lieu of paragraph  
32 (b), an additional yearly allowance of forty-five dollars for each year of creditable service or

33 fraction thereof; provided, that the total amount of said additional retirement allowance shall not  
34 exceed one thousand dollars in any case. Acceptance of this provision by a retirement system  
35 shall be by a majority vote of the board of each such system, subject to the approval of the  
36 legislative body. For the purposes herein, “legislative body” shall mean, in the case of a city, the  
37 city council in accordance with its charter, in the case of a town, the town meeting, in the case of  
38 a county, the county retirement board advisory council, in the case of a region, the regional  
39 retirement board advisory council, in the case of a district, the district members, and, in the case  
40 of an authority, the governing body. Acceptance shall be deemed to have occurred upon the  
41 filing of a certification of such votes with the commission. For purposes herein, the state  
42 teachers’ and state employees’ retirement systems shall be deemed to have accepted this  
43 provision.

44 SECTION 6. Paragraph (c) of subdivision (2) of section 26 of said chapter 32, as  
45 appearing, is amended by deleting the dollar amount “\$15” and inserting in place thereof the  
46 following dollar amount:- \$50 and is further amended by deleting in line 134 the dollar amount  
47 \$300 and inserting in place thereof the following dollar amount:- \$1,000.

48 SECTION 7. The provisions of this act shall be prospective from the date of acceptance  
49 of this act and shall not entitle a member, who is entitled to the benefits provided under this act,  
50 to any retroactive benefits.
