Resolve regarding revitalizing the right of free petition.

1           **Resolved**, regarding informing the population of Massachusetts about the use of the Right  
2   Of Free Petition; the use of Bills, Resolves, Resolutions, and Proposals for Constitutional  
3   Amendments.

4           It being the proper business of the persons of Massachusetts, to be able to intersect with  
5   their government, therefore The Right Of Free Petition, should be revitalized, by a series of steps  
6   considered by The Great And General Court, and its two legislative chambers.

7           This legislation requests and describes creation of a Special Committee and/or  
8   Commission of members of the House, and Senate, to consider how to publicize, educate, and  
9   disseminate information to the general population of Massachusetts, regarding the availability,

10 and processes for filing proposed legislative actions under the Right Of Free Petition: Bills,  
11 Resolves, Resolutions, and Proposals for Constitutional Amendments.

12 The Special Committee and/or Commission shall hold, well-publicized hearings, at both  
13 the State House, and in at least four other geographically disparate areas of The Commonwealth,  
14 to collect public comment regarding actions to be taken.

15 A suitable generally available publication shall be created, and disseminated by the  
16 Secretary of The Commonwealth, to provide general information as to how this right can be  
17 readily exercised. – It is the intent of this measure, that more individuals may bring forward,  
18 ideas, thoughts, and useful mechanisms, for the benefit of government, and our society.

19 This body shall be a membership appointed by the Speaker Of The House, President Of  
20 The Senate, and shall have representation of all political parties, including Unenrolled (non-  
21 party, Independents) from each body. Membership shall be appointed within three (3) months of  
22 passage.

23 This body shall have a lifespan of eighteen (18) months from the appointment of its  
24 members.
