1	SECTION 1. To provide for a program of transportation development and improvements,
2	the sum set forth in section 2 for the several purposes, and subject to the conditions specified in
3	this act, is hereby made available, subject to the laws regulating the disbursement of public
4	funds. The sum made available in this act shall be in addition to any amounts previously
5	appropriated or made available for these purposes.

53	SECTION 10. To meet the expenditures necessary in carrying out section 2, the state
54	treasurer shall, upon request of the governor, issue and sell bonds of the commonwealth in an
55	amount to be specified by the governor from time to time but not exceeding, in the aggregate,
56	\$225,000,000. All bonds issued by the commonwealth as aforesaid shall be designated on their
57	face, Commonwealth Transportation Improvement Act of 2023, and shall be issued for a
58	maximum term of years, not exceeding 30 years, as the governor may recommend to the general
59	court under section 3 of Article LXII of the Amendments to the Constitution. All such bonds

- 60 shall be payable not later than June 30, 2058, pursuant to said section 3 of said Article LXII. All
- 61 interest and payments on account of principal on these obligations shall be payable from the
- 62 General Fund. Notwithstanding any other general or special law to the contrary, bonds issued
- 63 under this section and interest thereon shall be general obligations of the commonwealth.
