An Act relative to the citizenship requirement to be appointed manager on a license for the sale of alcoholic beverages.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

| 6 | Immigration and Nationality Act, 8 U.S.C. 1101, or to any agent of any such person, or to any |
| 7 | corporation a majority of whose directors are in fact aliens, and no person not such a citizen or |
| 8 | such a qualified alien shall be appointed as manager or other principal representative of any |
| 9 | licensee; provided, that nothing herein shall prevent the granting of a license under section |
| 10 | eighteen A to any corporation organized under the laws of a foreign country or the granting of a |
| 11 | vehicle permit to such a corporation so licensed. |
| 12 | No corporation, organized under the laws of the commonwealth or of any other state or |

13 foreign country, shall be given a license to sell in any manner any alcoholic beverages unless

14 such corporation shall have first appointed, in such manner as the licensing authorities by 15 regulation prescribe, as manager or other principal representative, a citizen of the United States 16 or a qualified alien under the federal Immigration and Nationality Act, 8 U.S.C. 1101, and shall 17 have vested in him by properly authorized and executed written delegation as full authority and 18 control of the premises, described in the license of such corporation, and of the conduct of all 19 business therein relative to alcoholic beverages as the licensee itself could in any way have and 20 exercise if it were a natural person resident in the commonwealth, nor unless such manager or 21 representative is, with respect to his character, satisfactory to the licensing authorities.

No provision of this chapter shall impair any right growing out of any treaty to which theUnited States is a party.
