Dear Superintendent Zoldak:

The Massachusetts Department of Public Health, Community Sanitation Program (CSP) has received your Plan of Correction in response to the inspection conducted on June 30, July 3 and July 5, 2023. After review, the CSP finds the plan appropriately addresses all of the violations noted in the report with the following exceptions:

1. In regards to the issue of overcrowding, the CSP appreciates the limitations of correctional facilities and the need to accommodate the ever-increasing population; however we remain concerned with the overcrowded conditions.
2. Your Plan of Correction (POC) does not provide a date of completion for the purchase and installation of new warewash machines in the Tray Washing Rooms # 102 and 105 which requires DCAMM/DRM funding. While the CSP understands you do not have control over DCAMM's/DRM's allotment of funds, we cannot approve any item that does not identify a reasonable time frame for correction.
3. Please provide an estimated date of completion for repairs to be conducted on the dryers in the Property.
4. Please provide an estimated date for the development and implementation of cleaning schedules for the:
 - a. Spice Room #102 within the Food Service Building; and
 - b. Medium Freezer in the Warehouse.
