**The Children’s Medical Security Plan Legislative Report**  
**Fiscal Year 2024– 1st QUARTER**  
Reporting Period July 1, 2023 – September 30, 2023

The Children’s Medical Security Plan (CMSP) provides access to primary and preventive health care services to certain children and adolescents. Children from birth to age 18 are eligible for CMSP provided they are not eligible for other MassHealth benefits (except MassHealth Limited) and provided that they are not otherwise insured. Effective November 1, 2005, enrollee premiums were set at zero for those enrollees whose income is less than 200% of the Federal Poverty Level (FPL), and premiums are set via a sliding scale for enrollees with incomes of 200% of the FPL and above.

**Enrollment Demographics**

At the end of the first quarter of FY 2024 (September 30, 2023), there were 77,693 children eligible for CMSP. CMSP eligibility does not indicate that an eligible member is using CMSP services. Additional information on CMSP utilization can be found below.

**Total Expenditures**

The number of claims filed for CMSP for the first quarter of Fiscal Year FY 2024 totaled 164,725. There were 101,094 medical claims, 54,609 dental claims, and 9,022 pharmacy claims filed during the first quarter of the fiscal year. Total expenditures for the first quarter of the Fiscal Year 2024 were \$10,608,656. Based on year-to-date expenditures, annual spending for CMSP is estimated at \$30 million.
