An Act to improve the economy of the commonwealth.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Subsection (a) of section 19 of chapter 23K of the general laws is hereby  
2 amended by striking out clause (1) and inserting in place thereof the following clause (1):

3           “(1) region A: suffolk, middlesex, essex and norfolk counties;”

4           SECTION 2. Said subsection (a) of said section 19 of said chapter 23K, as so appearing,  
5 is hereby further amended by striking out, at the end of clause (2), the word “and”.

6           SECTION 3. Said subsection (a) of said section 19 of said chapter 23K, as so appearing,  
7 is hereby further amended by striking out, at the end of clause (3), the word “counties“ and  
8 inserting in place thereof the following words:-

9           “counties; and”

10           SECTION 4. Said subsection (a) of said section 19 of said chapter 23K, as so appearing,  
11 is hereby further amended by inserting after clause (3) the following clause (4):

12           “(4) region D: consisting of the cities and towns located in the Worcester Northern  
13 District Registry of Deeds, being Ashburnham, Fitchburg, Leominster, Lunenburg, and  
14 Westminster.”

15           SECTION 5. Said section 19 of said chapter 23K, as so appearing, is hereby further  
16 amended by inserting a new subsection (h), which shall provide as follows:

17           “(h) No gaming license shall be issued by the commission in region D unless it shall be  
18 situated on a site containing not less than 70 contiguous acres.”
