An Act authorizing common sense health services in assisted living.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Section 1 of chapter 19D of the General Laws, as appearing in the 2020  
2   Official Edition, is hereby amended by inserting after the definition of “Assisted living  
3   residence” or “Residence,” the following 2 definitions:-

4           “Basic health services”, injections; application or replacement of simple non-sterile  
5   dressings; management of oxygen on a regular and continuing basis when the resident's medical  
6   condition warrants; or application of ointments or drops and diagnostic services and functions  
7   necessary for carrying out these services including, but not limited to, glucose monitoring.

8           “Basic health services program”, an assisted living residence with an approved operating  
9   plan offering 1 or more basic health services.

10 SECTION 2. Subsection (b) of section 10 of said chapter 19D, as so appearing, is hereby  
11 amended by adding the following 2 paragraphs:-

12 (4) Assistance to residents with accessing telehealth services.

13 (5) For all residents whose service plans so specify, basic health services by personnel  
14 meeting standards for professional qualifications and training set forth in the regulations.

15 SECTION 3. Subsection (c) of said section 10 of said chapter 19D, as so appearing, is  
16 hereby amended by inserting after the word, “of”, in line 31, the following words: - basic health  
17 services or.

18 SECTION 4. Said section 10 of said chapter 19D, as so appearing, is hereby further  
19 amended by adding the following 4 subsections:-

20 (e) The sponsor may advertise, market and otherwise promote or provide or arrange for  
21 the provision of a basic health services program for assisted living residents and shall administer  
22 such care and services in accordance with the requirements set forth herein. A sponsor may not  
23 provide basic health services without submitting an operating plan to the department for the  
24 department’s approval that explains how the residence’s basic health services program will meet  
25 the needs of the residence’s resident population or individual residents therein and the staff  
26 qualifications and training for providing such services. The operating plan shall specify whether  
27 all, or certain, of the enumerated basic health services shall be offered, steps taken to provide  
28 adequate support and training to licensed practical nurses and registered nurses who shall  
29 provide such care and the oversight and evaluation of basic health services; provided, that no  
30 such plan shall restrict resident choice in the delivery of the services by outside health

31 professionals. The sponsor shall submit a revised operating plan to the department in the event of  
32 a change in the scope of the basic health services program offered to residents.

33 (f) The sponsor shall disclose to each resident the fees associated with provision of basic  
34 health services within the assisted living residence's residency agreement and shall review such  
35 fees with the resident upon implementation and any revision to a service plan that includes  
36 provision of basic health services. The sponsor shall notify residents of any changes in fees in a  
37 timely manner. Residents who receive basic health services shall receive an additional service  
38 plan review on a quarterly basis. Residents shall have the opportunity to discontinue receiving  
39 basic health services from the sponsor upon written request to the sponsor and shall not be  
40 charged a cancellation fee or a fee for services not provided due to discontinuation of the  
41 services.

42 (g) The department, in consultation with the department of public health, shall  
43 promulgate regulations governing the application, criteria for approval or disapproval and  
44 ongoing oversight of a basic health services program authorized in this section. The department  
45 may impose an annual fee on participating assisted living residences to pay for oversight of basic  
46 health services. The department may add additional services to the definition of basic health  
47 services.

48 (h) To ensure patient safety and clinical competence in the application of subsections (e)  
49 to (g), inclusive, the department and the department of public health shall establish and  
50 implement a plan to facilitate communication between the department and the department of  
51 public health and create a list of required components necessary for operating plans, including a  
52 requirement that when a residence is offering basic health services to 1 or more residents, staff

53 shall have access to a licensed practical nurse or registered nurse for consultation at all times and  
54 the nurse shall not be required to be on the premises. The department shall make available  
55 electronic copies of the required components of operating plans on the department's website. The  
56 department may conduct annual compliance reviews on the documentation created and  
57 maintained by assisted living residences for any assisted living resident who received basic  
58 health services within the previous 12-month period.

59 SECTION 5. Section 11 of said chapter 19D, as so appearing, is hereby amended by  
60 inserting after the word "supervision", in line 2, the following words:- except as permitted for  
61 residences which opt to provide basic health services.

62 SECTION 6. The joint committee on elder affairs shall conduct a review of the  
63 implementation of this act and the use of basic health services in assisted living not later than 5  
64 years after the effective date of this act.
