**In the One Hundred and Ninety-Fourth General Court
(2025-2026)**

An Act updating Chapter 30B.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 3 of chapter 30B of the General Laws, as appearing in the 2022
2 Official Edition, is hereby amended by striking out, in line 2, the figure “\$10,000”, and inserting
3 in place thereof the following figure:- \$15,000.

4 SECTION 2. Section 4 of chapter 30B of the General Laws, as so appearing, is hereby
5 amended by striking out subsection (a) and inserting in place thereof the following subsection:-

6 (a) Except as permitted pursuant to this section and section 7, for the procurement of a
7 supply or service for a governmental body in the amount of \$15,000 or greater, but not to exceed
8 \$100,000, a procurement officer shall seek written quotations from not fewer than 3 persons
9 customarily providing the supply or service. The procurement officer shall record the: (i) names
10 and addresses of all persons from whom quotations were sought; (ii) purchase description used
11 for the procurement; (iii) names of the persons submitting quotations; and (iv) date and amount
12 of each quotation. Such information shall be retained in the file required pursuant to section 3. A

13 governmental body may require that any procurement for the governmental body in an amount of
14 not more than \$100,000 shall be subject to section 5 or section 6.

15 SECTION 3. Said section 4 of chapter 30B, as so appearing, is hereby amended by
16 striking out, in line 21, the figure “\$10,000”, and inserting in place thereof the following figure:-
17 \$15,000.

18 SECTION 4. Section 5 of chapter 30B, as so appearing, is hereby amended by striking
19 out, in lines 2 to 4, the words “\$50,000 or, in the case of a municipal or regional school district,
20 award of procurement contracts in the amount of more than \$100,000,” and inserting in place
21 thereof the following figure:- \$100,000.

22 SECTION 5. Said section 5 of said chapter 30B, as so appearing, is hereby further
23 amended by striking out, in lines 40 and 41, the words “\$50,000, or, for a municipal or regional
24 school district, more than”.

25 SECTION 6. Section 6 of said chapter 30B, as so appearing, is hereby amended by
26 striking out, in lines 2 and 3, the words “\$50,000, or, a municipal or regional school district,
27 more than \$100,000” and inserting in place thereof the following figure:- \$100,000.

28 SECTION 7. Section 6A of said chapter 30B, as so appearing, is hereby amended by
29 striking out, in lines 2 and 3, the words “\$50,000, or, a municipal or regional school district,
30 more than \$100,000,” and inserting in place thereof the following figure:- \$100,000.

31 SECTION 8. Section 7 of said chapter 30B, as so appearing, is hereby amended by
32 striking out, in lines 2 and 3, the words “\$50,000, or, a municipal or regional school district,
33 more than \$100,000,” and inserting in place thereof the following figure:- \$100,000.

34 SECTION 9. Section 15 of said chapter 30B, as so appearing, is hereby amended by
35 striking out, in line 21, the figure “\$10,000”, and inserting in place thereof the following figure:-
36 \$15,000.

37 SECTION 10. Section 17 of said chapter 30B, as so appearing, is hereby amended by
38 striking out, in line 1, the figure “\$10,000”, and inserting in place thereof, the following figure:-
39 \$15,000.
