An Act relative to seeds.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Section 1 of Chapter 94C of the General Laws, as appearing in the 2022  
2 Official Edition, is hereby amended in line 237 by striking the following words:- the seeds  
3 thereof;

4           SECTION 2. Section 1 of Chapter 94C, as so appearing, is hereby further amended in  
5 lines 244 to 245 by striking out the words “or the sterilized seed of the plant which is incapable  
6 of germination” and replacing therein with the following words:-

7           the sterilized seed of the plant which is incapable of germination, or the seeds of the plant  
8 Cannabis sativa L.

9           SECTION 3. Section 1 of Chapter 94G of the General Laws, as so appearing in the 2022  
10 Official Edition, is hereby amended in lines 80 to 81 by striking the following words:- the seeds  
11 thereof;

12           SECTION 4. Section 1 of Chapter 94G, as so appearing, is hereby further amended in  
13 line 92 after the word “products” the following words:-

14           or (iv) the seeds of any plant of the genus Cannabis.

15           SECTION 5. Section 1 of Chapter 94I of the General Laws, as so appearing in the 2022  
16 Official Edition, is hereby amended in line 45 by striking the following words:- “the seeds  
17 thereof;”

18           SECTION 6. Section 1 of Chapter 94I, as so appearing, is hereby further amended in line  
19 57 after the word “products” the following words:-

20           or (iv) the seeds of any plant of the genus cannabis.
