**In the One Hundred and Ninety-Fourth General Court
(2025-2026)**

An Act relative to child protection.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Chapter 272 of the General Laws, as appearing in the 2022 Official
- 2 Edition, is hereby amended by striking out in section 28, the final sentence.
