An Act relative to an agricultural healthy incentives program.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Chapter 128 of the General Laws is hereby amended by inserting after  
2 section 2E the following section:-

3 Section 2F. (a) The department of transitional assistance, in partnership with the  
4 department of agricultural resources and the department of public health, shall operate a year-  
5 round healthy incentives program. The program shall provide that Supplemental Nutrition  
6 Assistance Program benefits, established pursuant to the Food and Nutrition Act of 2008, 7  
7 U.S.C. section 2011 hereinafter referred to as SNAP, redeemed for fruit and vegetable purchases,  
8 either fresh, canned, dried or frozen, by a SNAP recipient at a participating vendor, shall entitle  
9 the recipient to receive a matching benefit reimbursed on the recipient’s EBT card, within limits  
10 to be established by the department. When expanding the number of participating vendors, the  
11 department shall prioritize improving access in areas with limited access to fresh, local produce  
12 and that are historically underserved by the program. The department shall collaborate with local

13 food coalitions and nonprofit groups to develop community outreach strategies that ensure  
14 equitable access to, and knowledge of, the program.

15 (b) There shall be established and set up on the books of the commonwealth a separate  
16 fund, to be administered by the commissioner of the department of transitional assistance, which  
17 shall be known as the Massachusetts Healthy Incentives Fund. The Fund shall consist of all  
18 revenues from public and private sources as appropriations, gifts, grants, donations,  
19 reimbursements from the federal government and grants-in-aid or other receipts to further the  
20 purposes of the Fund in accordance with this section.

21 (c) The department of transitional assistance and its partners may apply for any available  
22 federal programs such as Gus Schumacher Nutrition Incentive Program administered by the  
23 United States department of agriculture to provide matching benefits to be deposited in the Fund.

24 (d) The department of transitional assistance shall, annually on or before January 31,  
25 submit a report of the healthy incentives program's activities to the clerks of the house and the  
26 senate, the house and senate committees on ways and means, the committee on children, families  
27 and persons with disabilities and the committee on agriculture and shall post the report on the  
28 department's website. The report shall include, but not be limited to: (i) the number of  
29 households utilizing the program, including household size, age and racial demographic  
30 information; (ii) the number of program transactions; (iii) the number and name of vendors  
31 processing program transactions; (iv) a breakdown of the total number of program participants  
32 and vendors, by their municipality; (v) the number of vendors, by their municipalities, who  
33 applied to be a vendor with the healthy incentives program but were not accepted as a vendor  
34 due to funding or administrative shortages; (vi) the department's efforts, plans and timeline for

35 identifying geographic areas that are underserved by the program and increasing program  
36 activity in those areas, including metrics and factors to be used to make determinations for the  
37 addition and siting of vendors; and (vii) any further recommendations to improve the  
38 performance of the program.

39 SECTION 2. The department of transitional assistance shall promulgate rules and  
40 regulations to implement the program set forth in section 1.
