Proposal for a legislative amendment to the Constitution for a Constitutional right to employable skills training.

A majority of all the members elected to the Senate and House of Representatives, in joint session, hereby declares it to be expedient to alter the Constitution by the adoption of the following Article of Amendment, to the end that it may become a part of the Constitution [if similarly agreed to in a joint session of the next General Court and approved by the people at the state election next following]:

### ARTICLE OF AMENDMENT.

1           ARTICLE OF AMENDMENT.

2           1.) The Constitution of The Commonwealth of Massachusetts, is hereby, and thus  
3 amended, to provide that:

4           Each, and every inhabitant of The Commonwealth of Massachusetts, has a Right to  
5 Employable Skills Training.

6           2.) The provision of this Right, with equality for all individuals, shall be subject to  
7 appropriate legislation by the Great and General Court. The Commonwealth of Massachusetts,  
8 shall have statutory, and regulatory authority, to accomplish the goals of this Constitutional  
9 Amendment.

10           3.) All legal residents of Massachusetts, shall be eligible for a Constitutional Right to  
11 Employable Skills Training, for the purposes of assisting in their degrees of self-sufficiency, in  
12 providing sound foundations for the economic health of our people, and Commonwealth, and for  
13 the strengthening of our neighborhoods, and communities.

14           4.) This Right, shall permit up to two (2) years of specific technical, or other employable  
15 skills training, in an accredited technical skills program, in such institutions, and their successors,  
16 as high schools, regional vocational technical schools, junior colleges, colleges, universities, and  
17 accredited for-profit schools. The tuition costs of this training, may be compensated by The  
18 Commonwealth of Massachusetts, entirely; and/or partially by other transparent partnership  
19 arrangements with employers, and/or other appropriate institutions. At the conclusion of such  
20 training, individuals shall be encouraged, and preferably have a bridge to specific employment  
21 positions.
