In the One Hundred and Ninety-Fourth General Court (2025-2026)

An Act enhancing post-pregnancy mental health care.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. Section 17C of chapter 32A of the General Laws, as appearing in the 2022
- 2 Official Edition, is hereby amended by inserting, in line 5, after the words "postpartum care" the
- 3 following words:-, including post-pregnancy mental health care.
- 4 SECTION 2. Said section 17C of said chapter 32A, as so appearing, is hereby further
- 5 amended by adding the following sentences:-
- 6 Coverage for post-pregnancy mental health care, including but not limited to postpartum
- 7 mental health care and post-miscarriage mental health care, provided under this section shall not
- 8 be subject to any deductible, coinsurance, copayment or any other cost-sharing requirement.
- 9 Coverage offered under this section shall not impose unreasonable restrictions or delays in the
- 10 coverage. Benefits for an enrollee under this section shall be the same for the enrollee's covered
- spouse and covered dependents. The commission shall ensure plan compliance with this chapter.
