## Criminal Justice Reform Report Q1 2026

### Plymouth County Sheriff's Office

#### Programs Division

**Pathways to Recovery** – Pathways to Recovery is a four-month substance use treatment program available to both sentenced and pretrial populations. The program utilizes an evidence-based, trauma-informed approach to address substance use disorders and support behavioral change. Oversight is provided by an independent licensed clinician, who supervises program staff and ensures the integrity and effectiveness of the curriculum through ongoing clinical guidance and review.

Program Manager Alexis Flaherty MS CHW

- Unit DN1 Sentenced program: 13 were admitted to the program, 2 non-disciplinary discharges, 0 disciplinary discharges, and 0 graduated the program. The average number of participants each month for the quarter was 9.
- Unit FS1 Trial program - 22 were admitted to the program, 3 disciplinary discharges, 14 non-disciplinary discharges, and 0 completed the program. Non-disciplinary discharges are released at court, bailed out, and programs placed. Average number of participants each month for the quarter is 17
- Narcan/Harm Reduction kits were offered to all releases, 40 were accepted.
- Number of Narcan Boxes dispensed from our Lobby machines 19
- AA and Refuge Recovery volunteers held groups in both sentenced and trial programs
- Brockton Neighborhood Health Center provides a Recovery Coach to offer a Relapse Prevention class and community outreach unit FS1.
- Plymouth Recovery Center provides Relapse prevention and community outreach/resources in the DN1 Program.

**Conflict Resolution:** A comprehensive 4-month conative behavioral program designed to address Criminal behavior, anger management, conflict, and victim impact. The objective is to help identify patterns, choices, and identify thinking errors. The goal is to assist them in finding alternative behaviors, healthy responses, emotional regulation, and reducing consequences.

Program Manager Sandra Crispin.

- 16 new participants began the program this quarter, and 0 graduated. They will graduate next month. 1 program failure for discipline, 6 non-disciplinary discharges. The average number of participants each month in the program was 11

**Making Changes Program:** 3-month Reentry preparation and life skills-based program. Ideally participants join this program 6 to 9 months prior to their release. The goal is discharging planning and identifying community resources to support each individual reentry plan and needs.

- 16 participants began the program, graduated from the program, 3 program failures for disciplinary reasons, 9 discharged non-disciplinary. The average number of participants each month in the program for the quarter is 12.
