**In the One Hundred and Ninety-Fourth General Court
(2025-2026)**

An Act authorizing an increase in the limit of a local excise tax that the city of Salem may impose for the purpose of funding school and municipal facilities.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Notwithstanding the six per cent limit on the amount of local excise tax that
2 a municipality other than the City of Boston may impose on the transfer of occupancy of any
3 room in a bed and breakfast establishment, hotel, lodging house, or motel contained in chapter
4 64G, section 3A of the General Laws, or any other general or special law to the contrary, the
5 City of Salem is hereby authorized to impose a local excise tax upon such transactions at a rate
6 not to exceed 8.75 per cent.

7 SECTION 2. The additional revenue attributable to the 2.75 percentage point increase
8 authorized by section 1, representing the difference between a local excise tax imposed at the
9 rate of 6 per cent and a local excise tax imposed at a rate up to 8.75 per cent, shall be deposited
10 into a separate special revenue fund to be established by the City of Salem.

11 Amounts deposited into said fund shall be used solely for the planning, design,
12 acquisition, construction, reconstruction, renovation, repair, improvement, furnishing, equipping,

13 maintenance, and extraordinary maintenance of school or municipal buildings and facilities of
14 the City of Salem, including, but not limited to, the payment of debt service on bonds or notes
15 issued for such purposes.

16 Nothing in this act shall be construed to limit, impair, or otherwise affect the eligibility or
17 authority of the City of Salem to apply for, receive, or expend grants, reimbursements, or other
18 financial assistance from the Massachusetts School Building Authority or any other federal,
19 state, or local source for the purposes described in this section.

20 Any balance remaining in the fund at the end of a fiscal year shall not revert to the
21 general fund and shall remain available for expenditure for the purposes set forth in this section.

22 SECTION 3. This act shall take effect upon its passage
