An Act relative to updating and modernizing Chapter 40R..

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Be it enacted by the Senate and House of Representatives in General Court assembled,

3 SECTION 1. Section 9 of chapter 40R of the General Laws, as so appearing, is hereby
4 amended by striking out subsections (a) and (b) and inserting in place thereof the following 2
5 subsections:-

6 (a) The commonwealth shall pay from the trust fund or other funds from appropriations
7 or other money authorized by the general court a zoning incentive payment, according to the
8 following schedule:

	Projected Units of New Construction%	Payment
10	Up to 20%	\$20,000
11	21 to 100%	\$150,000
12	101 to 200%	\$400,000

13 201 to 500% \$740,000

14 501 or more% \$1,200,000

16 Subject to any conditions imposed by the department as a condition of approving a smart
17 growth zoning district or starter home zoning district, the zoning incentive payment shall be
18 payable upon confirmation of approval of the district by the department. The projected number
19 of units shall be based upon the zoning adopted in the smart growth zoning district or starter
20 home zoning district.

21 (b) The commonwealth shall pay from the trust fund or other funds from appropriations
22 or other money authorized by the general court a 1-time density bonus payment to each city or
23 town with an approved smart growth zoning district and a 1-time production bonus payment to
24 each city or town with an approved starter home zoning district. This payment shall be \$6,000
25 for each housing unit of new construction created in the smart growth zoning district and \$6,000
26 for each housing unit of new construction created in the starter home zoning district. The amount
27 due shall be paid on a unit-by-unit basis in accordance with department regulations, upon
28 submission by a city or town of proof of issuance of a building permit for a particular housing
29 unit or units within the district.”

30 SECTION 2. Section 12 of Chapter 40R of the General Laws is hereby amended by
31 inserting in line 3, after the word “review”, the following words:-

32 “, including but not limited to an analysis of the incentive payments, in Section 9, to
33 determine that those payments are consistent with housing costs per the Consumer Price Index.”

34 SECTION 3. This act shall take effect for tax years beginning on or after January 1,
35 2025.

36 SECTION 4. Notwithstanding any other section of the law to the contrary, no later than
37 10 years after the date of enactment, the increased incentives, as identified in section 1 and
38 section 2, shall revert back to their original figures.
