An Act relative to enhancing statewide hospital capacity coordination.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Notwithstanding any general or special law to the contrary, the department  
2 of public health (“the department”) shall create a real-time, statewide, Hospital Capacity  
3 Coordination Dashboard. To support these efforts, the department of public health shall  
4 collaborate with healthcare providers with clinical, emergency management, and hospital  
5 operations expertise and members of the legislature. This dashboard shall be a real-time,  
6 electronic tool to, at a minimum, gather, report, and facilitate data related to managing hospital  
7 capacity, capability, and available beds in hospitals across the Commonwealth in the event of a  
8 public health emergency or other surge in patient need.

9           Said data should ensure and understanding of relevant individual hospital, regional, and  
10 statewide bed availability. The department may also include other data points as deemed relevant

11 to the purpose of monitoring local, regional, and statewide hospital capacity and capability,  
12 situational awareness, and facilitation of patient load balancing efforts.

13 SECTION 2. The department, the executive office of technology services, and the  
14 executive office of health and human services shall provide the staffing and funding for this  
15 dashboard and the operational costs for the final Hospital Capacity Coordination Dashboard,  
16 subject to future appropriation by the legislature explicitly for this purpose.

17 SECTION 3. Upon completion of the electronic Hospital Capacity Coordination  
18 Dashboard tool and any corresponding governance or use guideline documents, a healthcare  
19 coalition, representing medical providers broadly, shall assume control of the Dashboard, and  
20 manage the operations of this tool, and be given administrative control of the tool, including the  
21 data produced for and by the Hospital Capacity Coordination Dashboard.

22 SECTION 4. Within 1 year following the effective date of this act, the department shall  
23 complete the electronic tool.
