By Mr. Fattman, a petition (accompanied by bill, Senate, No. 2467) of Ryan C. Fattman and Bruce E. Tarr for legislation to authorize amend update and align the Commonwealth’s definition of veteran. Veterans and Federal Affairs.

The Commonwealth of Massachusetts

**In the One Hundred and Ninety-Fourth General Court
(2025-2026)**

An Act authorizing amending, updating, and aligning the Commonwealth’s definition of veteran.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Section 7, clause forty-third of chapter 4 of the General Laws, as appearing in the 2022
2 Official Edition, is hereby amended by striking clause forty-third in its entirety and inserting in
3 place thereof the following:-

4 "Forty-third, "Veteran" shall mean (1) a person who served on active duty in the
5 Uniformed Services or on full time national guard or reserve duty, under Titles 10 or 32 of the
6 United States Code or under sections 38, 40 and 41 of chapter 33, and (2) who was discharged or
7 released therefrom under conditions other than dishonorable; (3) a member of the American
8 Merchant Marine who served in armed conflict between December 7, 1941 and December 31,
9 1946, and who was discharged or released therefrom under conditions other than dishonorable;
10 (4) a member of the reserve component who has served s minimum of six years as an active
11 drilling member of the reserve component; or (5) any person who served in the Uniformed

12 Services, and was awarded a service-connected disability by the U.S. Veterans Administration or
13 who died in such service under conditions other than dishonorable shall be deemed a veteran.

14 "Active Duty" shall include (1) full time service; and (2) any period of active or inactive
15 duty for training during which the individual was disabled or died.

16 "Armed Forces" shall include army, marine corps, navy, air force, space force, coast
17 guard and any additional military service created by the U.S. Department of Defense including
18 reserve components thereof.

19 "Uniformed Services" shall include armed forces, commissioned corps of the public
20 health service and commissioned corps of the national oceanic and atmospheric administration.

21 None of the following shall be deemed to be a "veteran":

22 (a) Any person who at the time of entering into the armed forces of the United States had
23 declared his intention to become a subject or citizen of the United States and withdrew his
24 intention under the provisions of the act of Congress approved July ninth, nineteen hundred and
25 eighteen.

26 (b) Any person who was discharged from the said armed forces on his own application or
27 solicitation by reason of his being an enemy alien.

28 (c) Any person who has been proved guilty of willful desertion.

29 (d) Any person whose only service in the armed forces of the United States consists of his
30 service as a member of the coast guard auxiliary or as a temporary member of the coast guard
31 reserve, or both.

32 (e) Any person whose last discharge or release from the armed forces is dishonorable."
