## The Commonwealth of Massachusetts

In the One Hundred and Ninety-Fourth General Court (2025-2026)

An Act preserving access to treatment for patients with serious mental illnesses.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 1 of Chapter 1760 of the Massachusetts general laws is hereby 2 amended by inserting the following new definition: -3 "Serious mental illness," any of the following conditions, as defined by the most recent 4 edition of the Diagnostic and Statistical Manual of Mental Disorders: 5 (1) Bipolar disorders, hypomanic, manic, depressive, and mixed. 6 (2) Childhood and adolescent depression. (3) Major depressive disorders, single episode or recurrent. 7 8 (4) Obsessive-compulsive disorders. 9 (5) Paranoid personality disorder and other psychotic disorders. 10 (6) Schizo-affective disorders, bipolar or depressive.

13	SECTION 2. Section 12A of said Chapter 176O is hereby further amended by inserting
14	after subsection (g) the following new subsection:-
15	(h) Notwithstanding any other provision of law, a carrier or utilization review
16	organization shall not, with respect to a drug approved by the Food and Drug Administration for
17	the treatment of serious mental illness, impose a prior authorization requirement, step therapy
18	protocol, or any other protocol that could restrict or delay the dispensing of the drug.
19	SECTION 3. Section 8 of Chapter 118E of the Massachusetts general laws is hereby
20	amended by inserting therein the following new definition:-

22	recent edition of the Diagnostic and Statistical Manual of Mental Disorders:
23	(1) Bipolar disorders, hypomanic, manic, depressive, and mixed.

SECTION 4. Section 51A of said chapter 118E is hereby further amended by inserting after subsection (f) the following new subsection: -

(g) Notwithstanding any other provision of law, the division or an entity with which the division contracts to provide or manage health insurance benefits shall not, with respect to a drug approved by the Food and Drug Administration for the treatment of serious mental illness, impose a prior authorization requirement, step therapy protocol, or any other protocol that could restrict or delay the dispensing of the drug.
