An Act bringing Mass Save in line with climate mandates.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. The title of section 19 of chapter 25 of General Laws, as appearing in the
2 2022 Official Edition, is hereby amended by inserting after the words “funding for energy
3 efficiency,” the following words:- and decarbonization.

4 SECTION 2. The title of section 19 of chapter 25 of General Laws, as appearing in the
5 2022 Official Edition, is hereby amended by striking out the words “gas energy efficiency
6 programs” .

7 SECTION 3. Section 19 of chapter 25 of General Laws, as appearing in the 2022 Official
