Communications Access Trust Fund Report

Section 2E, line 1595-6153 of the FY25 GAA requires the Executive Office for Administration and Finance to submit a report including:

- (a) the distribution of the funds appropriated in this item to sheriffs' offices and the department of corrections;
- (b) the barriers to providing calls free of charge to incarcerated individuals; and
- (c) the current volume of calls at sheriffs' offices and the department of corrections.

Department of Correction (DOC)

Per the reporting required in subsections “(a)” and “(c),” here is the distribution of funds appropriated in this item (1595-6153) to the Department of Correction (DOC) in FY25, and the corresponding volume of calls:

Regarding the reporting required in subsection “(b),” DOC notes that the barriers to providing calls free of charge to incarcerated individuals include:

- Costs associated with providing free phone calls, which also includes free video visits and email correspondences
 - The Department is currently observing around a 165% increase in volume/usage compared to November 2023 (the last month before free phone calls were implemented and commissions ceased).
- Funding to the Communications Access Trust Fund (CATF):

- The CATF was appropriated \$10M in FY25. DOC's spending was over \$10M (phone calls/video visits, fees, and emails). DOC's Fiscal Services Division could not seek reimbursement for June 2025 costs due to the low CATF balance, and hence that monthly cost (approximately \$850K) had to be absorbed in DOC's operating budget.

Sheriffs' Offices

Regarding the costs and volume of calls for the Massachusetts Sheriffs' offices in Fiscal Year 2025 (FY25), please see the tables below for data provided to A&F by the Massachusetts Sheriffs' Association (MSA).

Additionally, please note that the Administration included approximately \$12.5M for Sheriffs' no-cost calls expenses in our originally filed FY25 closeout budget bill. The legislature subsequently appropriated these funds (\$12.5M) through line item 1595-6153 contained in Chapter 73 of the Acts of 2025.
