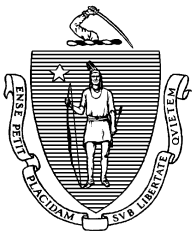

Dear Sheriff Tompkins:

The Massachusetts Department of Public Health (Department) Division of Environmental Health Regulations and Standards (EHRS) conducted an inspection of the Suffolk County Jail on November 3, 2025, accompanied by Sergeant Tyler Crocker, Environmental Health and Safety Officer, and Lieutenant Brittany Carroll, in accordance with Department regulations 105 CMR 451.000: Minimum Health and Sanitation Standards and Inspection Procedures for Correctional Facilities.

The inspection identified 149 total deficiencies: 81 new deficiencies under the Required Standards (.100 and .200 series), 30 repeat deficiencies under the Required Standards, 31 new deficiencies under the Recommended Standards (.300 series), and 7 repeat deficiencies under the Recommended Standards.

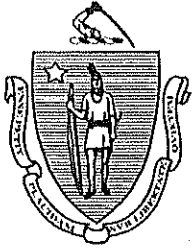



Dear Sheriff Tompkins:

The Massachusetts Department of Public Health (Department) Division of Environmental Health Regulations and Standards (EHRS) conducted an inspection of the Suffolk County Jail on November 3, 2025, accompanied by Sergeant Tyler Crocker, Environmental Health and Safety Officer, and Lieutenant Brittney Carroll, in accordance with Department regulations 105 CMR 451.000: Minimum Health and Sanitation Standards and Inspection Procedures for Correctional Facilities.

The inspection identified 149 total deficiencies: 81 new deficiencies under the Required Standards (.100 and .200 series), 30 repeat deficiencies under the Required Standards, 31 new deficiencies under the Recommended Standards (.300 series), and 7 repeat deficiencies under the Recommended Standards.

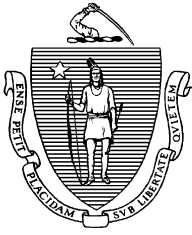


- DCAMM project will take place in 3 phases to ensure the health and safety of all inmates and staff at the facility.

- Consigli will have an assigned cleaning crew on site in the facility to ensure the areas under construction at those times remain clean for the health and safety of the population and staff.



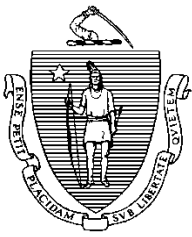
Kitchen Area:

The Massachusetts Department of Public Health (Department) Division of Environmental Health Regulations and Standards (EHRS) conducted an inspection of the Suffolk County Jail on November 3, 2025, accompanied by Sergeant Tyler Crocker, Environmental Health and Safety Officer, and Lieutenant Brittney Carroll, in accordance with Department regulations 105 CMR 451.000: Minimum Health and Sanitation Standards and Inspection Procedures for Correctional Facilities.

The inspection identified 149 total deficiencies: 81 new deficiencies under the Required Standards (.100 and .200 series), 30 repeat deficiencies under the Required Standards, 31 new deficiencies under the Recommended Standards (.300 series), and 7 repeat deficiencies under the Recommended Standards.

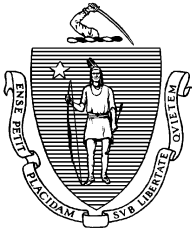
