Department of Public Utilities Unified Carrier Registration Trust Fund

Between November 7, 2024, and November 12, 2025, the Department of Public Utilities collected \$2,305,259.17 in revenue and expended \$2,008,100.73 from the Unified Carrier Registration Trust Fund, for an unexpended balance of \$992,302.81.

The spending from the Unified Carrier Registration Trust is to fund the payroll and administration costs, including vehicle, office supplies, training, travel, and reimbursements for fourteen full-time staff to administer the Federal Unified Carrier Registration program, as well as enforcement activities in conjunction with the Massachusetts State Police.
