In accordance with Section 2E of Chapter 9 of the Acts of 2025, I am submitting a Fiscal Year 2026 transfer schedule for the Clean Energy Investment Fund at the Massachusetts Clean Energy Technology Center.

- 1595-6232 -- Clean Energy Investment Fund, established in section 15 of said chapter 23J of the General Laws, for clean energy workforce development initiatives and investments to support emissions reductions in the energy, transportation and buildings sectors, including investments to support entrepreneurial fellowships enabling the translation of research into businesses, products and jobs in the energy, transportation and buildings sectors. [NOTE: Although the General Appropriation Act continues to reference the Clean Energy Investment Fund, Chapter 238 of the Acts of 2024 changed the name of that fund to the Climatetech Investment Fund.]
