An Act relative to campaign reporting..

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Section 18 of chapter 55 of the General Laws, as appearing in the  
2 2008 Official Edition is hereby amended by deleting the first paragraph and inserting in place  
3 thereof the following paragraph:-

4           Section 18. Each candidate and each treasurer of a political committee shall, if  
5 the candidate is seeking the office of mayor in a municipality with a total population, as  
6 determined by the most recent federal decennial census of more than 40,000 persons, or if the  
7 candidate or the candidate's committee, during the election cycle, can reasonably expect to raise  
8 or spend more than \$5,000, or if the committee is required to file such reports with the director  
9 pursuant to section 19, file with the director or, if the candidate seeks public office at a city or  
10 town election, or if the committee is organized for the purpose of a city or town election, with the  
11 city or town clerk, reports of contributions received and expenditures made on forms to be

12 prescribed by the director. A candidate for nomination or election to the office of mayor in a city  
13 and any non-elected political committee organized on behalf of such candidate, who files such  
14 reports in accordance with clause (b), shall file a copy of any such report with the director. A  
15 committee organized under the provisions of section five to favor or oppose a question submitted  
16 to the voters shall file its reports with the director if the question appears on ballots at a state  
17 election, or with the city or town clerk if the question appears on ballots at a city or town election  
18 or for use in a city or town at a state election.
