By Ms. Andrews of Orange, a petition (accompanied by bill, House, No. 3003) of Denise Andrews and others relative to establishing an autism spectrum disorder designation on driver’s licenses and identification cards and criminal justice training relative to Autism Spectrum Disorder. Transportation.

The Commonwealth of Massachusetts

In the Year Two Thousand Thirteen

An Act establishing an autism spectrum disorder designation on driver’s licenses and identification cards and criminal justice training relative to autism spectrum disorders.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Chapter 90 of the General Laws is hereby amended by inserting after
2 section 8M the following section:-

3 Section 8N. (a) A resident who is diagnosed with an autism spectrum disorder may
4 request to have a notation of such diagnosis placed on a Commonwealth issued driver’s license
5 or identification card. Such applicant shall present the registry of motor vehicles with a sworn
6 statement from a qualified medical professional licensed in Massachusetts verifying such
7 diagnosis. Applicant must provide the registry with permission to make public this diagnosis on
8 their Commonwealth issued driver’s license or identification card.

9 (b) The registrar shall establish procedures necessary to carry out the provisions of this
10 section including, without limitation, application forms to include a waiver of liability for the
11 release of any medical information and an appropriate symbol to be placed on the drivers’
12 licenses and identification cards.

13 SECTION 2. Section 116 of Chapter 6 of the General Laws, as appearing in the 2010
14 Official edition, is hereby amended by inserting the following section after Section 116E:—

15 Section 116F:

16 A. The municipal police training committee shall establish within the recruit basic
17 training curriculum a course for regional and municipal police training schools on or before

18 January first, two thousand and fourteen for the training of law enforcement officers in the
19 commonwealth in appropriate interactions with persons diagnosed with an autism spectrum
20 disorder, and also shall develop guidelines for law enforcement response to individuals with
21 autism spectrum disorders who are victims or witnesses to crime, or suspected or convicted of
22 crime.

23 The course of instruction and the guidelines shall stress positive responses to such
24 individuals, de-escalating potentially dangerous situations, understanding of the different manner
25 in which such individuals process sensory stimuli and language, and appropriate methods of
26 interrogation.

27 Where appropriate, the training presenters shall include experts on autism spectrum
28 disorders who also have expertise in the law enforcement or corrections field.

29 As used in this section, “law enforcement officer” shall mean any officer of a local police
30 department, capital and state police, and “correction officer” shall mean any officer tasked with
31 the custody, care, or transport of incarcerated or detained persons. As used in this section,
32 “autism spectrum disorder” shall mean a disability on the autism spectrum, which includes but
33 may not be limited to autistic disorder, Asperger's disorder, pervasive developmental disorder
34 not otherwise specified, childhood disintegrative disorder, nonverbal learning disorder, or Rhetts
35 Syndrome, as defined in such professional guidelines as the Diagnostic and Statistical Manual of
36 the American Psychiatric Association.

37 B. The course of basic training for law enforcement officers and correction officers shall,
38 no later than January first, two thousand and fourteen, include at least eight hours of instruction
39 in the procedures and techniques described below:

40 (aa) The nature and manifestations of autism spectrum disorders.

41 (bb) Appropriate techniques for interviewing or interrogating an individual with an
42 autism spectrum disorder, including techniques to ensure legality of statements made, and
43 techniques to protect the rights of the interviewee.

44 (cc) Techniques for locating an individual with an autism spectrum disorder who runs
45 away, and returning said individual while causing as little stress as possible to him or her.

46 (dd) The legal duties imposed on police officers to offer protection and assistance,
47 including guidelines for making felony and misdemeanor arrests, and appropriate techniques for
48 arrest and restraint on an individual with an autism spectrum disorder.

49 (ee) Techniques for de-escalating a potentially dangerous situation to maximize the safety
50 of both the law enforcement officer or correction officer and the individual with an autism
51 spectrum disorder.

52 (ff) Techniques for differentiating between an individual with an autism spectrum
53 disorder from an individual who is belligerent, uncooperative, or otherwise displaying traits
54 similar to the characteristics of an individual with an autism spectrum disorder.

55 (gg) Procedures to ensure the safety and well-being of individuals with an autism
56 spectrum disorder in a correctional facility.

57 (hh) The impact of interaction with law enforcement officers or correction officers on
58 individuals with an autism spectrum disorder.

59 C. All law enforcement recruits shall receive the course of basic training for law
60 enforcement officers, established in subsections (A) and (B), as part of their required
61 certification process.
