An Act reducing the sales tax to 5%. .

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Section 2 of chapter 64H of the General Laws, as appearing in the 2010
- 2 Official Edition, is hereby amended by striking the words “6.25 per cent” and inserting in place
- 3 thereof the words “5.6 per cent”.
- 4 SECTION 2. Section 2 of said chapter 64H, as so appearing, is hereby amended by
- 5 striking the words “6.25 per cent” and inserting in place thereof the words “5 per cent”.
- 6 SECTION 3. Section 2 of Chapter 64I of the General Laws, as appearing in the 2010
- 7 Official Edition, is hereby amended by striking the words “6.25 per cent” and inserting in place
- 8 thereof the words “5.6 per cent”.
- 9 SECTION 4. Section 2 of said chapter 64I, as so appearing, is hereby amended by
- 10 striking the words “6.25 per cent” and inserting in place thereof the words “5 per cent”.
- 11 SECTION 5. Section 1 of this act shall take effect on August 1, 2013.
- 12 SECTION 6. Section 2 of this act shall take effect on August 1, 2014.
- 13 SECTION 7. Section 3 of this act shall take effect on August 1, 2013.
- 14 SECTION 8. Section 4 of this act shall take effect on August 1, 2014.
