SUMMARY

This bill establishes August 10th as Agent Orange Awareness Day in Massachusetts, requiring the governor to issue an annual proclamation recognizing the day.

The observance is intended to honor Vietnam War veterans who were exposed to Agent Orange. By doing so, the Commonwealth formally adds Agent Orange Awareness Day to its list of official commemorative observances.

The Commonwealth of Massachusetts

In the One Hundred and Ninety-Fourth General Court
(2025-2026)

An Act making August 10th Agent Orange Awareness Day in Massachusetts.

Whereas, The deferred operation of this act would tend to defeat its purpose, which is to designate forthwith August 10th Agent Orange Awareness Day, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Part I, Title II, Chapter 6, of the Massachusetts General Laws (M.G.L.) Section
2 15XXXXX: "The governor shall annually issue a proclamation setting apart August 10th as
3 Agent Orange Awareness Day and recommending that the day be observed in an appropriate
4 manner by the people."

5 WHEREAS, our nation was conceived by individuals who were willing to sacrifice their
6 safety and concerns to ensure our individual and collective freedom, and the Commonwealth is
7 especially proud to be the home of so many valiant men and women who have performed above
8 and beyond the call of duty. The citizens of the United States have, throughout the years, been
9 called upon to take up arms against the enemies of this great nation, risking their lives and

10 leaving their loved ones behind to honorably safeguard the freedoms and liberties guaranteed to
11 all Americans and vanquishing those who threaten our way of life; and

12 WHEREAS, more than eight million citizens of this country honorably served during the
13 Vietnam War, during which time Agent Orange was widely used in Vietnam by the United
14 States Armed Forces as part of the herbicidal warfare program Operation Ranch Hand from 1961
15 until 1971. Nearly 20 million gallons of the orange powder were sprayed over the land from
16 helicopters or low-flying aircraft, destroying vegetation and crops to deprive enemy guerrillas of
17 food and cover for their activities and exposing 2.6 million American soldiers to the herbicide
18 and defoliant chemical; and

19 WHEREAS, Agent Orange is a dioxin and cancer-causing chemical that enters the body
20 through physical contact or ingestion and moves into the human cell nucleus, where it attacks the
21 genes and causes a number of serious illnesses, including leukemia, lymphoma, myeloma,
22 ischemic heart disease, soft tissue sarcoma, amyloidosis, diabetes, and cancers of the throat,
23 prostate, lung, and colon. Agent Orange also causes genetic damage, and in some cases, the
24 children and grandchildren of veterans exposed to Agent Orange have been born with spina
25 bifida and other abnormalities. Today, only 800,000 Vietnam veterans exposed to Agent Orange
26 are alive, and approximately 300 deaths occur among them every day; and

27 WHEREAS, while fallen comrades are memorialized on The Wall at the Vietnam
28 Veterans Memorial in Washington, D.C., those veterans who are victims of Agent Orange are
29 not recognized as fatalities of the Vietnam War; and

30 WHEREAS, it is most appropriate that we should honor these veterans to the full extent
31 of our ability, as they have made untold and innumerable sacrifices to preserve the liberties we

32 enjoy today and that our progeny will hopefully continue to cherish for generations to come;
33 now, therefore,

34 WHEREAS, the Commonwealth of Massachusetts honors and recognizes the victims of
35 Agent Orange during the Vietnam War for their courageous service to our nation as some of
36 America's most heroic citizens.

37 THEREFORE, the Commonwealth of Massachusetts officially declares August 10th as
38 Agent Orange Awareness Day and recognizes it as such.

Chapter 6: Sets out the organization, duties, and commemorative observances of the Commonwealth's executive branch.

SUMMARY

This bill amends Chapter 6 of the Massachusetts General Laws by adding Section 15FFFFFF, which designates May 2 as Veterinary Youth Day. It requires the governor to issue an annual proclamation to raise awareness of veterinary medicine, the shortage of veterinarians, and the importance of animal welfare, and encourages schools and communities to partner with local veterinarians and animal shelters to expose students to career opportunities in the field.

In the One Hundred and Ninety-Fourth General Court
(2025-2026)

An Act relative to veterinary youth day.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Chapter 6 of the General Laws is hereby amended by inserting after Section
2 15EEEEEEE, added by chapter 32 of the acts of 2025, the following section:-

3 Section 15FFFFFFF. The governor shall annually issue a proclamation setting apart May
4 2 as Veterinary Youth Day to call attention to the youth of the commonwealth to get involved in
5 veterinary medicine, to raise awareness of the shortage of veterinarians in commonwealth and
6 the importance of animal welfare and to call for schools, individuals and communities to partner
7 with local veterinarians and animal shelters in the commonwealth to expose students to careers in
8 veterinary medicine and shall recommend that the day be observed in an appropriate manner by
9 the people.
