## JOURNAL OF THE HOUSE.

Tuesday, March 12, 2002.

Met according to adjournment, at eleven o'clock A.M., in an Informal Session, with Mr. Walsh of Boston in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

## Petitions.

Mr. Patrick of Falmouth presented a petition (subject to Joint Rule 12) of Matthew C. Patrick relative to consumers who received default service resulting from the restructuring of the electric utility industry; and the same was referred, under Rule 24, to the committee on Rules.

By Mr. Rogers of Norwood, for the committee on Ways and Means, that the Bill authorizing the Commissioner of the Division of Capital Asset Management and Maintenance to convey certain land in the town of Westborough (House, No. 4844) ought to pass.

By Mr. Rogers of Norwood, for the committee on Ways and Means, that the Bill authorizing the

Division of Capital Asset Management and Maintenance to convey certain easements to the city of Gardner (House, No. 4821) ought to pass. Referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

Mr. Kujawski of Webster, for said committee, reported that the matter be scheduled for consideration by the House; and, under said rule, it was placed in the Orders of the Day for the next sitting for a second reading.
