Subsequently Mr. Scaccia of Boston, for said committees, reported, asking to be discharged

from further consideration of said the order; and recommending that the same be referred to the House committee on Rules. Under Rule 42, the report was considered forthwith; and it was accepted.

By Mr. Binienda of Worcester, for the committee on Energy, on a petition, a Bill relative to energy efficient appliances (House, No. 4956).

By Mr. Donnelly of Boston, for the committee on the Judiciary, on a petition, a Bill providing for an assistant clerk in the Milford District Court (House, No. 4972).

Severally read; and referred, under Rule 33, to the committee on Ways and Means.

By Mr. Rodrigues of Westport, for the committee on Commerce and Labor, on Senate, No. 87, a Bill further regulating business practices between motor vehicle manufacturers, distributors and dealers (House, No. 4997). Read; and referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

#### Recess.

At four minutes after eleven o'clock A.M., on motion of Mr. Finneran of Boston (Mr. Wagner of Chicopee being in the Chair), the House recessed until a quarter after two o'clock P.M.; and at twenty-three minutes after two o'clock the House was called to order with Mr. Scaccia of Boston in the Chair.

# Message from the Acting Governor.

A message from Her Honor the Lieutenant-Governor, Acting Governor, recommending legislation relative to improving management and security at Logan Airport (House, No. 4996) was filed in the office of the Clerk on Tuesday, April 2.

The message was read; and it was referred, under Rule 30, with the accompanying draft of a bill, to the committee on Transportation. Sent to the Senate for concurrence.

## Guests of the House.

During the session, the Chair (Mr. Scaccia of Boston) declared a recess subject to the call of the Chair, there being no objection; and introduced the 2001-2002 Division I State Champion Waltham High School hockey team. The team, accompanied by Head Coach John MaGuire and staff, Athletic Director Bill Foley, Principal John Graceffa, School Superintendent Dr. Susan Parella, former State Representative and current Mayor David F. Gately and Mayor Gately's former intern Brian Dudley, were the guests of Representatives Stanley of Waltham and Koutoujian of Newton as well as Senators Fargo and Tollman.

During the session, Mr. Lepper of Attleboro took the Chair and declared a recess subject to the call of the Chair, there being no objection; and introduced the Attleboro High School boys gymnastics team, State Champions for the second year in a row. The team, accompanied by Head Coach Mike Martin and Assistant Coach Rich Butler, were the guests of Representative

Lepper.

#### Resolutions.

Resolutions (filed with the Clerk by Mr. Correia of Fall River) honoring Comendador Heitor Miguel De Medeiros Sousa, were referred, under Rule 85, to the committee on Rules.

Mr. DiMasi of Boston, for the committee on Rules, then reported that the resolutions ought to be adopted. Under suspension of the rules, on motion of Mr. Cabral of New Bedford, the resolutions (reported by the committee on Bills in the Third Reading to be correctly drawn) were considered forthwith; and they were adopted.

# Paper from the Senate.

The House Bill relative to the Korean War Veterans Memorial Highway (House, No. 4577) came from the Senate passed to be engrossed, in concurrence, with an amendment in line 3 inserting after the word "Holyoke" the following: ", excluding the bridge previously designated as the Vietnam Veterans Memorial Bridge by chapter 26 of the acts of 1982,".

Under suspension of Rule 35, on motion of Mr. Wagner of Chicopee (Mr. Scaccia of Boston having returned to the Chair), the amendment (reported by the committee on Bills in the Third Reading to be correctly drawn) was considered forthwith; and it was adopted, in concurrence.

# Emergency Measure.

The engrossed Bill designating a certain bridge in the town of Sharon as the Lance Corporal Daniel J. Dabreu Memorial Bridge (see Senate, No. 2190, amended), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 9 to 0. Sent to the Senate for concurrence.
