## JOURNAL OF THE HOUSE.

Monday, April 8, 2002.

Met at seven minutes after one o'clock P.M., in an Informal Session, with Mr. DiMasi of Boston in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

Quinn (by vote of the town) (with the approval of the county commissioners) that the Bristol County Retirement Board be directed to increase the retirement allowance paid to Louis Caton, a retired police officer of the town of Dartmouth. Under suspension of the rules, on motion of Ms. Balser of Newton, the report was considered forthwith. Joint Rules 12 and 7A were suspended; and the petition (accompanied by bill) was referred to the committee on Public Service. Sent to the Senate for concurrence.

Mr. Scaccia of Boston, for the committee on Rules, on the Order relative to authorizing the committee on Public Safety to make an investigation and study of certain House documents concerning motorized scooters, motorcycle awareness and training programs, the regulation of jet skis and snowmobiles and other related matters (House, No. 4580) reported, in part, asking to be discharged from further consideration

Of the petition (accompanied by bill, House, No. 1267) of Bradford Hill and other members of the General Court that motorcycle awareness programs be included in driver education courses;

Of the petition (accompanied by bill, House, No. 3170) of Thomas J. O'Brien and other members of the General Court that cities and towns be authorized to establish regulations for the control of jet skis, surf jets and other personal watercraft;

Of the petition (accompanied by bill, House, No. 3810) of Thomas J. O'Brien, Viriato Manuel

deMacedo and Michael E. Festa for legislation to further regulate the operation of jet skis; and

Of the petition (accompanied by bill, House, No. 3815) of Eric Turkington, Matthew C. Patrick, Shirley Gomes and Ruth W. Provost relative to further regulating jet skis;

And recommending that the same severally be recommitted to the committee on Public Safety.

Under Rule 42, the reports severally were considered forthwith; and they were accepted.

Mr. Scaccia of Boston, for the committee on Rules, on the Order relative to authorizing the committee on Public Safety to make an investigation and study of certain House documents concerning the issuance of firearm identification cards and licenses, the use of chemical mace and the sale of handguns in the Commonwealth (House, No. 4581) reported, in part, asking to be discharged from further consideration of the petition (accompanied by bill, House, No. 3169) of Thomas J. O'Brien, other members of the General Court and another relative to the quarterly payment of certain firearms license fees,— and recommending that the same be recommitted to the committee on Public Safety. Under Rule 42, the report was considered forthwith; and it was accepted.

Mr. Scaccia of Boston, for the committee on Rules, asking to be discharged from further consideration of the residue of the Order relative to authorizing the committee on Public Safety to make an investigation and study of certain House documents concerning the issuance of distinctive license plates in the Commonwealth (House, No. 4582),— and recommending that the same be recommitted to the committee on Public Safety. Under Rule 42, the report was considered forthwith; and it was accepted.

Mr. Scaccia of Boston, for the committee on Rules, on the Order relative to authorizing the committee on Public Safety to make an investigation and study of certain House documents concerning speed limit violations, pedestrian safety, state police, lock-up facilities and other related public safety matters (House, No. 4593) reported, in part, asking to be discharged from further consideration

Of the petition (accompanied by bill, House, No. 2580) of Paul C. Casey relative to the establishment of regional lock-up facilities; and

Of the petition (accompanied by bill, House, No. 2587) of Thomas N. George relative to authorizing the use of the correctional facility in Barnstable County as a regional lockup facility;

And recommending that the same severally be recommitted to the committee on Public Safety.

Under Rule 42, the reports severally were considered forthwith; and they were accepted.

Mr. Scaccia of Boston, for the committee on Rules, on the Order relative to authorizing the committee on Public Safety to make an investigation and study of certain House documents concerning various boards within the Executive Office of Public Safety, school bus safety, Registry of Motor Vehicles rebate programs and other related matters (House, No. 4599) reported, in part, asking to be discharged from further consideration of so much of the recommendations of the Registry of Motor Vehicles (House, No. 173) as relates to the

establishment of registration rebate rules and provisions (accompanied by bill, House, No. 185),— and recommending that the same be recommitted to the committee on Public Safety. Under Rule 42, the report was considered forthwith; and it was accepted.

Mr. Scaccia of Boston, for the committees on Rules of the two branches, acting concurrently, asking to be discharged from further consideration of the Bill protecting the natural and historic resources of the Commonwealth (Senate, No. 2281),— and recommending that the same be referred to the committees on Rules. Under Rule 42, the report was considered forthwith; and it was accepted.

Mr. Scaccia of Boston, for the committee on Rules, on the Order relative to authorizing the committee on Public Service to make an investigation and study of certain House documents concerning active and retired public employees (House, No. 4312) reported, in part, asking to be discharged from further consideration of the petition (accompanied by bill, House, No. 2072) of John H. Rogers relative to the retirement rights of school committee appointees,—and recommending that the same be referred to the committee on Ways and Means. Under Rule 42, the report was considered forthwith; and it was accepted.

By Mr. Kujawski of Webster, for the committee on Steering, Policy and Scheduling, that the House Bill establishing a certain voting subprecinct in the city of Newton (House, No. 4977) [Local Approval Received] be scheduled for consideration by the House.

Under suspension of Rule 7A, on motion of Ms. Balser of Newton, the bill was read a second time forthwith; and it was ordered to a third reading.

By Mr. Rogers of Norwood, for the committee on Ways and Means, that the Bill providing for local government workforce reduction through an early retirement incentive program for certain employees (House, No. 4978) ought to pass with an amendment substituting therefor a bill with the same title (House, No. 5007).

Referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

Mr. Kujawski of Webster, for said committee, reported that the matter be scheduled for consideration by the House; and, under said rule, it was placed in the Orders of the Day for the next sitting for a second reading, with the amendments previously recommended by the committee on Counties on the part of the House; and the amendment recommended by the committee on Ways and Means, pending.

By Mr. Rogers of Norwood, for the committee on Ways and Means, that the Bill including employees of the Central Massachusetts Regional Planning Commission in the group insurance plan (Senate, No. 2131) ought to pass. Referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

Mr. Kujawski of Webster, for said committee, reported that the matter be scheduled for consideration by the House; and, under said rule, it was placed in the Orders of the Day for the next sitting for a second reading.

By Mr. Kujawski of Webster, for the committee on Steering, Policy and Scheduling, that the

Mr. Rogers of Norwood, for the committee on Ways and Means, under the provisions of House Rule 30, reported a Bill making appropriations for the fiscal year 2002 to provide for supplementing certain existing appropriations and for certain other activities and projects (House, No. 5006) Read; and referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

Mr. Kujawski of Webster, for said committee, reported that the matter be scheduled for consideration by the House; and, under said Rule 7A, the bill was placed in the Orders of the Day for the next sitting for a second reading.

### Engrossed Bills.

The engrossed Bill designating a certain bridge in the town of Sharon as the Lance Corporal Daniel J. Dabreu Memorial Bridge (see Senate, No. 2190, amended) (which originated in the Senate), in respect to which the Senate had concurred in adoption of the emergency preamble, was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate.

The engrossed Bill relative to a voting precinct in the town of Dracut (see House bill printed in House, No. 4954) (which originated in the House), having been certified by the Clerk to be

rightly and truly prepared for final passage, was passed to be enacted (more than two-thirds of the members having agreed to pass the same); and it was signed by the acting Speaker and sent to the Senate.

Engrossed bills

Providing for a charter for the town of Sandwich (see Senate, No. 2192, changed) (which originated in the Senate);

Providing for the establishment and administration of rent regulations and the control of evictions in manufactured housing communities in the town of Kingston (see House, No. 4845); and

Authorizing the city of Easthampton to grant an additional license for the sale of all alcoholic beverages to be drunk on the premises (see House, No. 4871);

(Which severally originated in the House);

Severally having been certified by the Clerk to be rightly and truly prepared for final passage, were passed to be enacted; and they were signed by the acting Speaker and sent to the Senate.

Mr. Travis of Rehoboth being in the Chair,—

The engrossed Bill relative to the financial conditions in the town of Swansea (see House, No. 4935) (which originated in the House), having been certified by the Clerk to be rightly and truly prepared for final passage, was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate.

The House Bill appointing the clerk of the town of Brookfield to the board of selectmen of the town (printed in House, No. 4998), reported by the committee on Bills in the Third Reading to be correctly drawn, was read a third time; and it was passed to be engrossed. The House Bill relative to reduction of sewer fee liability in the town of Dedham in exchange for volunteer services by persons over age sixty (House, No. 4445) was read a third time.

The committee on Bills in the Third Reading reported recommending that the bill be amended by striking out section 2.

The amendment was adopted; and the bill (House, No. 4445, amended) was passed to be engrossed. Sent to the Senate for concurrence.
