Authorizing the park commissioners of the town of Rochester to change the use of a certain parcel of municipal land acquired for outdoor recreational and athletic uses (House, No. 855) [Local Approval Received];

By Mr. Tobin of Quincy, for the committee on Criminal Justice, on House, Nos. 3501 and 3911, a Bill creating the crime of criminal solicitation (House, No. 3501).

By Mr. Cahill of Beverly, for the committee on Housing and Urban Development, on House, Nos. 2702, 3324 and 3325, a Bill to enhance safety in public housing (House, No. 4123).

Severally read; and referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.

Engrossed Bill.

The engrossed Bill relative to an election to fill a vacancy in the board of selectmen of the

town of Walpole (see House bill printed in House, No. 4110) (which originated in the House), having been certified by the Clerk to be rightly and truly prepared for final passage, was passed to be enacted (more than two-thirds of the members having agreed to pass the same); and it was signed by the Speaker and sent to the Senate.

Motion to Reconsider.

Mr. Miceli of Wilmington moved that the vote be reconsidered by which the House, at the preceding sitting, passed to be engrossed the House Bill authorizing the Commissioner of the Division of Capital Asset Management and Maintenance to convey a certain parcel of land in the town of Tewksbury (House, No. 4111); and the motion to reconsider was considered forthwith and it prevailed.

Pending the recurring question on passing the bill to be engrossed, the same member moved that it be amended in section 7, in lines 14 to 19, inclusive, by striking out the sentence contained therein and inserting in place thereof the following sentence:— "As an additional condition of said conveyance, the majority of the board of trustees of the Tewksbury hospital then sitting, the executive director of said hospital and the commissioner of the department of public health shall confirm in writing two weeks prior to conveyance that the parcel described in section 3 is needed to protect the aquifer and water supply for said Tewksbury hospital."

The amendment was adopted; and the bill (House, No. 4111, amended) was passed to be engrossed. Sent to the Senate for concurrence.
