Pending the question on adoption of the resolutions, further consideration thereof was postponed, on further motion of Mr. Rogers of Norwood, until after disposition of the matters first called in the Orders of the Day.

Subsequently the matters first called in the Orders of the Day having been disposed of, the resolutions were further considered.

Mr. Marini of Hanson and other members of the House then moved that the resolutions be amended in line 16 by striking out the figures "15,906,895,000" and inserting in place thereof the figures "15,793,000,000".

After remarks on the question on adoption of the amendment, Mr. Marini asked for a count of the House to ascertain if a quorum was in attendance. A count showed that 83 members were in attendance.

After debate on the question on adoption of the amendment (Mr. Flynn of Bridgewater being in the Chair), the sense of the House was taken by yeas and nays, at the request of Mr. Rogers of Norwood; and on the roll call 22 members voted in the affirmative and 127 in the

negative.

Mr. Finneran then moved that the House adjourn; and the motion prevailed. Accordingly, without further consideration of the remaining matters in the Orders of the Day (Mr. Flynn

of Bridgewater being in the Chair), at one minute before three o'clock P.M. the House adjourned, to meet on Thursday next at eleven o'clock A.M., in an Informal Session
