JOURNAL OF THE HOUSE.

Thursday, May 24, 2001.

Met according to adjournment, at eleven o'clock A.M., in an Informal Session, with Mr. Bosley of North Adams in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

Prayer was offered by the Reverend Robert F. Quinn, C.S.P., Chaplain of the House, as follows:

Gracious and Merciful God, upon Whom we depend for guidance and courage, teach us to recognize Your presence in our midst at this and every moment throughout the day. May we remain open to Your assistance as we address the legislative issues of the day. In legislative and personal matters, grant us the vision and the integrity to do what is honorable, right and acceptable in Your sight. In celebrating Memorial Day on Monday, a national holiday, we remember with gratitude the sacrifices of the men and women who died in our nation's conflicts and wars. As a people, we are grateful to them for the political, religious and intellectual freedoms which we enjoy as citizens of this country. Bestow Your blessings on the Speaker, the members and employees of this House and their families. Amen.

At the request of the Chair (Mr. Bosley), the members, guests and employees joined with him in reciting the pledge of allegiance to the flag.

Guests of the House.

During the session, the Chair (Mr. Bosley of North Adams) declared a recess subject to the call of the Chair, there being no objection; and introduced the Roxbury Community College "Tigers" basketball team, accompanied by Head Coach Malcolm Wynn and Assistant Coach John Jackson. The National Championship team, with a record of 31 wins and 1 loss, were the guests of Representatives Fox of Boston and Honan of Boston.

Resolutions.

Resolutions (filed with the Clerk by Mr. Ayers of Quincy) congratulating Doctor Diane Willard on the occasion of her retirement, were referred, under Rule 85, to the committee on Rules.

Mr. Honan of Boston, for the committee on Rules, then reported that the resolutions ought to be adopted. Under suspension of the rules, on motion of Mrs. Walrath of Stow, the resolutions (reported by the committee on Bills in the Third Reading to be correctly drawn) were considered forthwith; and they were adopted.

Of the petition (accompanied by bill, House, No. 1686) of Marie J. Parente, Anthony J. Verga and Kevin G. Honan that the Department of the State Auditor be authorized to conduct audits of certain municipal and county accounts; and

Of the petition (accompanied by bill, House, No. 3631) of Theodore C. Speliotis relative to liability of costs to the Commonwealth and its departments involving certain construction at Danvers State Hospital;

And recommending that the same severally be referred to the committee on Ways and Means.

Under Rule 42, the reports severally were considered forthwith; and they were accepted. Severally sent to the Senate for concurrence in the discharge of the committee.

By Mr. Kujawski of Webster, for the committee on Steering, Policy and Scheduling, that the Senate Bill relative to the practice of public accountancy (Senate, No. 369) be scheduled for consideration by the House.

Under suspension of Rule 7A, on motion of Mr. Nyman of Hanover, the bill was read a second time forthwith; and it was ordered to a third reading.

By Mr. Quinn of Dartmouth, for the committee on Banks and Banking, on House, Nos. 8 and 12, a Bill relative to debt collection and loan servicing agencies subject to regulation by the Division of Banks (House, No. 12).

By the same member, for the same committee, ought NOT to pass, on the petition (accompanied by bill, House, No. 628) of Bruce J. Ayers for legislation to regulate personal injury protection to operators of uninsured motor vehicles.

By the same member, for the same committee, ought NOT to pass, on the petition (accompanied by bill, House, No. 3942) of Brian M. Cresta and Richard R. Tisei relative to prescription drug coverage under certain insurance policies.

By Mr. Toomey of Cambridge, for the committee on Public Safety, ought NOT to pass, on the petition (accompanied by bill, House, No. 860) of John A. Hart, Jr., and Stephen F.

Lynch for legislation to prohibit the issuance of drivers' licenses to persons with poor school attendance and school dropouts.

Severally referred, under Rule 7A, to the committee on Steering, Policy and Scheduling.
