## JOURNAL OF THE HOUSE.

Wednesday, July 17, 2002.

Met according to adjournment, at eleven o'clock A.M., with Mrs. Walrath of Stow in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

Prayer was offered by the Reverend Robert F. Quinn, C.S.P., Chaplain of the House, as follows:

God of Forgiveness and Truth, we pause for a moment of spiritual reflection to recognize Your presence and to ask for Your assistance as we organize and sort out our personal and legislative priorities, agenda and pending decisions. # Reports of Committees.

By Mr. Scaccia of Boston, for the committee on Rules, that the Bill clarifying tastings (House, No. 4814) ought to pass with an amendment substituting therefor a bill with the same title (House, No. 5247). Referred, under Rule 33, to the committee on Ways and Means with the amendment pending.

By Mr. Cahill of Beverly, for the committee on Housing and Urban Development, on House, Nos. 4686 and 4971, an Order relative to authorizing the committee on Housing and Urban Development to make an investigation and study of certain House documents concerning a parcel of land in the city of Fall River (House, No. 5245). Referred, under Joint Rule 29, to the committees on Rules of the two branches, acting concurrently.

Mr. Scaccia of Boston, for said committees, reported asking to be discharged from further consideration of said order; and recommending that the same be referred to the House committee on Rules. Under Rule 42, the report was considered forthwith; and it was accepted.

Subsequently, the same member, for the same committee on Rules, reported, in part, on the foregoing order, a Bill relative to the implementation of a housing improvement plan in the city of Fall River (House, No. 4686) [Local Approval Received]; and

On the the residue of the foregoing order, the same member reported, a Bill relative to the implementation of a housing improvement plan in the city of Fall River (House, No. 4971) [Local Approval Received].

Severally read; and referred, under Rule 33, to the committee on Ways and Means.

By Mr. Cahill of Beverly, for the committee on Housing and Urban Development, on House, No. 5145, a Bill relative to the disposition of certain state-owned property in the town of Belmont (House, No. 5248).

By Mrs. Parente of Milford, for the committee on Long-Term Debt and Capital Expenditures, on a message from Her Honor the Lieutenant-Governor, Acting Governor, a Bill providing for capital facility improvements and repairs for the Commonwealth (printed in House, No. 5037). [General Obligation Bonds: \$101,804,155.00].

By the same member, for the same committee, on House, No. 5120, a Bill relative to certain capital spending authorizations (House, No. 5249) [Deauthorization of General Obligation Bonds: \$568,500,000.00].

Severally read; and referred, under Rule 33, to the committee on Ways and Means.

Orders of the Day.

The Senate Bill authorizing farmer-brewers to sell malt beverages on Sundays and legal holidays (Senate, No. 373), reported by the committee on Bills in the Third Reading to be correctly drawn, was read a third time; and it was passed to be engrossed, in concurrence.

House bills

Authorizing the city of Waltham to continue the use of certain park land for water purposes (House, No. 4833);

Designating a certain bridge in the town of Andover as the Joseph A. Horan Bataan Corrigidor Veterans Memorial Bridge (House, No. 5022);

Relative to the repair of a certain road in the city of Leominster (House, No. 5118); and

Relative to the terms of certain bonds issued by the Commonwealth (House, No. 5198);

Severally reported by the committee on Bills in the Third Reading to be correctly drawn, were read a third time; and they were passed to be engrossed. Severally sent to the Senate for concurrence.

The House Bill providing for increased organ donations through education and access (House, No. 4238, amended) was considered, the main question being on ordering the bill to a third reading.

The amendments previously recommended by the committee on Ways and Means,—that the bill be amended in section 1 by striking out the sentence contained in lines 4 to 9, inclusive, and inserting in place thereof the following sentence: "The registrar shall provide to those persons licensed to operate a motor vehicle under this chapter who have signified their intention to make an anatomical gift under the provisions of chapter 113 access to information on federally designated organ procurement organizations so as to facilitate the level of communication between and reciprocal knowledge of said persons and said organizations on the issue of organ donation.", by striking out in lines 9 and 10 the words "mutually agreeable format" and inserting in place thereof the following "a manner and form to be determined by the registration following consultation with federally designated organ procurement organizations"; in section 2, in line 6, by inserting after the word "available" the words "to said clients",— were rejected.

Mr. George of Yarmouth then moved that the bill be amended by substitution of a bill with the same title (House, No. 5246), which was read.

The amendment was adopted; and the substituted bill was ordered to a third reading.

Recess.

At twenty-five minutes after eleven o'clock A.M., the Chair (Mrs. Walrath of Stow) declared a recess, subject to the call of the Chair.


