The engrossed Bill relative to the charter of the city known as the town of Watertown (see House, No. 4478) came from the Senate with an amendment in section 24, in line 1 (as engrossed), by striking out the word "This" and inserting in place thereof the following: "Notwithstanding section 42C of chapter 54 of the General Laws, this".

Under suspension of Rule 35, on motion of Ms. Kaprielian of Watertown, the amendment (a report of the committee on Bills in the Third Reading asking to be discharged from further consideration thereon having been accepted) was considered forthwith; and it was adopted, in concurrence.

A petition of Andrea F. Nuciforo, Jr., and Shaun P. Kelly for legislation to authorize the Division of Capital Asset Management and Maintenance to release certain easements to O'Connell Oil Associates, Inc., came from the Senate referred, under suspension of Joint Rule 12, to the committee on State Administration.

The House then concurred with the Senate in the suspension of said rule; and the petition (accompanied by bill, Senate, No. 2136) was referred, in concurrence, to the committee on State Administration.
